Re: Snow Teeth Whitening's Continuing Use of FDA logo

Dear Sir or Madam:

On July 10, 2019, we notified your office that the Arizona-based dental cosmetics company Snow Teeth Whitening was improperly using an FDA logo in violation of the FDA's Logo Policy. Specifically, the company was prominently featuring an FDA logo in its marketing materials, including on its product packaging, website, and social media platforms, as well as falsely stating on its website and in Google ads that the company's product is FDA-approved.

Soon after alerting your office to this issue, Snow Teeth Whitening removed the FDA-approved claims from its website and Google ads, as well as the FDA logo from select marketing materials, including certain images of its product packaging featured on its website and social media pages. However, despite giving the appearance that it has remedied its marketing, Snow Teeth Whitening continues to feature the FDA logo in several other marketing materials. These materials – which are all still in publication as of today, four weeks after TINA.org's initial letter regarding Snow Teeth Whitening's misconduct – include, but are not limited to, website images and videos, social media advertisements and posts, YouTube videos, and images on third-party marketing and selling platforms.




