Re: Neymar Junior's NFT Promotions

Dear Mr. de Dios Crespo-Pérez:

I am writing to you on behalf of Truth in Advertising, Inc. ("TINA.org"), a nonprofit consumer advocacy organization dedicated to protecting consumers from deceptive advertising.

We are aware that Neymar Junior has promoted certain non-fungible token (NFT) companies on his social media channels, including, for example, Bored Ape Yacht Club and NFTStar. While TINA.org is not currently addressing a specific deceptive marketing issue pertaining to such posts, we have found that celebrity NFT promotions is an area rife with deception, including, but not limited to, a failure to clearly and conspicuously disclose the promoter's material connection to the endorsed NFT company, as well as the omission of other material information, such as the risks associated with investing in such speculative digital assets, the financial harm that can result from such investments, and the personal benefit(s) the promoter may gain by virtue of the promotion(s).

To the extent that Mr. Junior has a material connection to any of the NFT companies or brands promoted in his social media feeds that may not be obvious to those viewing his posts, TINA.org urges him to immediately disclose those material connections wherever
