Dear Ms. Smith and Ms. Patten:

On behalf of the Administrator of General Services, Denise Turner Roth, and the U.S. General Services Administration's (GSA) Chief of Staff, Katy Kale, thank you for your letter dated March 11, 2016, requesting that GSA address the products offered for sale on its GSAAdvantage! website that Truth in Advertising, Inc. has identified as being mislabeled as "Made in the United States of America."

The Administrator has requested that GSA's Federal Acquisition Service (FAS), which manages the Multiple Award Schedules (MAS) program and the GSAAdvantage! website, respond to your concerns.

FAS has reviewed the identified errors internally, taken action as appropriate, and will seek opportunities to continue to improve the agency's ability to identify potential misrepresentations of place of manufacture for products awarded on the MAS contracts. The enclosed addendum details the disposition for each of the 118 part numbers on the database that Truth in Advertising, Inc. shared with GSA.

Before awarding a MAS contract, GSA requires prospective contractors to self-certify that the products to be offered comply with the Trade Agreements Act (TAA); the TAA requires that end products be made in the United States or a designated country. In addition, a MAS contractor seeking to add new products to its MAS contract using a contract modification must certify that the new products are TAA-compliant.

Although GSA samples for compliance but does not verify each part number on a MAS contractor's "Made in the U.S.A." self-certification, GSA will conduct an immediate investigation and require that the "Made in the U.S.A" notation be removed from a product if GSA learns that a product is not in fact made in the U.S.A.

As part of GSA's continued efforts to ensure quality contract administration with respect to compliance with the TAA, GSA is currently exploring ways to strengthen agency communications with contractors and employ additional tools in that effort, such as IT systems and increased compliance sampling.

GSA appreciates you bringing the identified items to the agency's attention.
