1 Defendant The Hain Celestial Group Inc., by and through its  
2 attorneys Covington & Burling LLP, and Plaintiff Lauren Crivier, by and through  
3 her attorneys Kirtland & Packard LLP, filed a stipulation to transfer this case to  
4 the U.S. District Court for the Northern District of California. The parties have  
5 reached a settlement in principle that resolves Plaintiff's claims, pursuant to which  
6 the parties have agreed to transfer this litigation for consolidation with the related  
7 action *Brown v. The Hain Celestial Group, Inc.*, No. 3:11-cv-03082-LB, for class
