**TO ALL PARTIES AND THEIR ATTORNEYS OF RECORD:**

**PLEASE TAKE NOTICE THAT** on February 20, 2012 at 9:00 a.m., or as soon thereafter as this matter may be heard by and before the Honorable Phyllis J. Hamilton, United States District Judge, at the United States Courthouse, Oakland Courthouse, Courtroom 3, 3rd Floor, 1301 Clay Street, Oakland, California 94612, Plaintiffs Desiree Stephenson, Marni Haber, and Karva Tam (“Plaintiffs”), on behalf of the proposed Class (defined herein), respectfully apply to this Court for entry of an order: (i) granting preliminary approval of the proposed settlement set forth in the class action Stipulation of Settlement (attached as Exhibit 1 to the accompanying Declaration of Mark N. Todzo (“Todzo Decl.”)); (ii) conditionally certifying the Class for purposes of such settlement by way of a [Proposed] Order Granting Preliminary Approval (submitted herewith); (iii) approving Plaintiffs’ selection of Class Counsel; (iv) approving the proposed notice plan; and (v) setting a hearing date for final approval thereof.

This motion is based on this Notice of Motion and Motion, the attached Memorandum of Points and Authorities, the other papers on file in this action, and such other submissions or arguments that may be presented before or at the hearing on this motion.

1 **MEMORANDUM OF POINTS AND AUTHORITIES**

2 **INTRODUCTION**

3 Plaintiffs Desiree Stephenson, Marni Haber, and Karva Tam (“Plaintiffs”) on behalf of the  
4 proposed Class (defined herein), respectfully apply to this Court for entry of an order (i) granting  
5 preliminary approval of the proposed settlement set forth in the class action Stipulation of  
6 Settlement (the “Settlement Agreement”) (Todzo Decl. Exh. 1); (ii) conditionally certifying the  
7 Class for purposes of such settlement by way of a [Proposed] Order Granting Preliminary  
8 Approval (the “Preliminary Approval Order”) (submitted herewith); (iii) approving Plaintiffs’  
9 selection of Class Counsel; (iv) approving the proposed notice plan; and (v) setting a hearing date  
10 for final approval thereof (the “Final Approval Hearing”).

11 The proposed settlement resolves the claims in the Second Amended Complaint in the  
12 above captioned case, which concerns Neutrogena’s allegedly false and misleading marketing and  
13 advertising of its Neutrogena Naturals line of cleansers and moisturizers as “natural” products that  
14 contain no petrochemicals. The lawsuit alleges that six of these products are, in fact, not made of  
15 natural ingredients and do, in fact, contain petrochemicals.<sup>1</sup> The settlement remedies the concerns  
16 expressed in the lawsuit Plaintiffs filed on behalf of all purchasers of these products, who paid a  
17 premium for them over comparable products that did not purport to be natural or free of  
18 petrochemicals.

19 The proposed settlement is fair, reasonable, and adequate, falling well within the range of  
20 class action settlements that merit preliminary approval. First and foremost, this settlement will  
21 prevent future violations by requiring Neutrogena to change its product labeling to accurately  
22 reflect the contents inside. In addition, Neutrogena will pay a total of \$1,300,000 into a settlement  
23 fund for the benefit of Class members. Neutrogena will also not oppose an application by  
24 Plaintiffs to this Court for a partial reimbursement of Plaintiffs’ attorneys’ fees and costs, not to

1 exceed a total of \$500,000. In turn, Neutrogena will receive a release of all claims relating to the  
2 challenged marketing and advertising practices. These settlement stipulations were reached after  
3 rigorous, informed negotiations between the parties and their experienced class action counsel, in  
4 a process that was overseen by a seasoned, neutral mediator. Because this proposed settlement is  
5 fair to all parties and because it adequately addresses the grievances of Plaintiffs and the Class, it  
6 should be preliminarily approved.

## 7 **STATEMENT OF FACTS**

### 8 **I. PROCEDURAL AND FACTUAL BACKGROUND**

9 Defendant Neutrogena is a manufacturer, seller, and distributor of a line of skincare  
10 products known as Neutrogena Naturals (the “Products”), which are sold to consumers across the  
11 nation, including in California. Plaintiffs allege that they were induced to purchase the Products  
12 by Neutrogena’s representations and claims that the Products are natural; in fact, Plaintiffs allege,  
13 the Products contain various artificial and synthetic ingredients. Plaintiff further allege that certain  
14 statements made by Neutrogena in marketing and advertising the Products, including that they  
15 contain “[n]o harsh chemical sulfates, parabens, petrochemicals, dyes, phthalates,” are false and  
16 misleading. Plaintiffs seek to represent a class of persons throughout the United States who, like  
17 themselves, purchased the Products at a price premium, erroneously believing them to be natural  
18 based on Neutrogena’s representations. The primary objectives of Plaintiffs’ case are to: (1)  
19 require Neutrogena to halt its allegedly deceptive marketing and advertising practices (thereby  
20 protecting consumers in the future); and (2) to disgorge the premiums it allegedly obtained as a  
21 result of its misrepresentations (thereby compensating consumers for past wrongdoings).

22 On January 26, 2012, Plaintiff Desiree Stephenson filed a Complaint against Neutrogena in  
23 the U.S. District Court for the Northern District of California. The Complaint alleged (1)  
24 violations of California’s Unfair Competition Law (“UCL”), Cal. Bus. & Prof. Code § 17200 *et*  
25 *seq.*; California’s False Advertising Law (“FAL”), Cal. Bus. & Prof. Code § 17500 *et seq.*; and  
26 California’s Consumer Legal Remedies Act (“CLRA”), Cal. Civ. Code § 1750 *et seq.*; and (2)  
27 breach of express warranty with regard to four Neutrogena Naturals “cleanser” products: the  
28

1 Purifying Facial Cleanser, Purifying Pore Scrub, Face and Body Bar, and Fresh Cleansing +  
2 Makeup Remover. On March 28, 2012, Plaintiff Stephenson filed a First Amended Complaint  
3 alleging the same causes of action, but adding two additional Neutrogena Naturals “moisturizer”  
4 products: the Multi-Vitamin Nourishing Night Cream and Multi-Vitamin Nourishing Moisturizer.

5 On July 27, 2012, the Court granted in part and denied in part Neutrogena’s Motion to  
6 Dismiss, dismissing claims as to the five Products that Plaintiff Stephenson did not purchase and  
7 striking Plaintiff Stephenson’s prayer for injunctive relief insofar as she did not adequately allege  
8 a risk of future injury. However, the Court gave Plaintiff Stephenson leave to file an amended  
9 complaint to add allegations that she intends to purchase Neutrogena Naturals Products in the  
10 future if the alleged misrepresentations are corrected. On October 26, 2012, Plaintiffs filed a  
11 Second Amended Complaint adding these allegations, and also adding Marni Haber and Karva  
12 Tam – two California residents who purchased the Products under the misguided belief that they  
13 were natural and contained no petrochemicals – as named Plaintiffs and putative Class  
14 representatives. Neutrogena filed an Answer to that Second Amended Complaint on November 9,  
15 2012.

16 Even prior to the Court’s July 27, 2012 Order on Neutrogena’s Motion to Dismiss, the  
17 parties had begun discussions regarding the underlying factual allegations and potential settlement  
18 options. On August 7, 2012, the parties participated in a settlement mediation with the Honorable  
19 Edward A. Panelli (Retired). During the course of the mediation session and thereafter,  
20 Neutrogena provided Plaintiffs with vital information pertinent to the legitimacy and scope of  
21 Plaintiffs’ claims, including sworn statements to Plaintiffs confirming the composition and  
22 labeling of the Neutrogena Naturals products and the number of products sold to date. These  
23 discussions and the mediation resulted in the settlement terms discussed below. Although  
24 Neutrogena has numerous defenses to the underlying allegations and the basis for certifying the  
25 Class, in recognition of the risks of the litigation and the certain, significant costs of defending it,  
26 Neutrogena agreed to a settlement that will provide valuable benefits to the settlement Class.

## II. THE PROPOSED SETTLEMENT

In exchange for a release of all claims, Neutrogena has agreed to undertake several important remedial measures. First, to remedy the alleged misrepresentations on the Product labels, Neutrogena has agreed to change its Product labeling. Second, Neutrogena will contribute \$1.3 million into an independently-administered Class fund, which will be used chiefly to compensate users of the Products who were misled by Neutrogena's past labeling practices, as well as to disseminate notice to the Class such that affected persons may avail themselves of this remedial monetary payment. Third, Neutrogena will pay for a portion of Plaintiffs' reasonable attorneys' fees and costs, which shall not exceed \$500,000.

### A. Neutrogena Must Change Its Business Practices So As To Be Truthful In Labeling And Packaging Its Products.

In settlement of Plaintiffs' and the Class's claims, Neutrogena has agreed to prospectively change the labeling and, where applicable, packaging of all Products. In order to cure any misperception that the Products are all-natural, Neutrogena will include a statement regarding the exact percentage of the Product that is naturally derived on the front of the labels and/or packages of each Product. In addition, Neutrogena will remove the term "petrochemicals" from the statement "No harsh chemical sulfates, parabens, petrochemicals, dyes, phthalates" on the Product labels in order to cure the alleged misrepresentation resulting from Plaintiffs' contention that the Products contain petrochemical residues. Todzo Decl. Exh. 1, ¶ III.A; *see also id.*, Exh. 1-H.

### B. Neutrogena Must Contribute Substantial Sums To A Claim Fund To Compensate Those Persons Harmed By Its Allegedly Deceptive Labeling And Marketing Practices.

The Settlement Agreement also provides that Neutrogena will pay \$1.3 million to establish a fund (the "Claim Fund") for payment of Class member claims, and for the payment of certain notice and administration costs and expenses. Todzo Decl. Exh. 1, ¶ III.B. The Claim Fund will be administered by an independent, qualified company (the "Claim Administrator"), which shall approve claims submitted by affected Class members in accordance with a specified procedure and subject to verification by the parties. *Id.*, Exh. 1, ¶¶ III.B.4, III.B.6, III.B.7; *see also id.*, Exh. 1-A. Class members who submit valid claims are eligible to recover up to \$10 per member (\$1 for

1 each of the cleanser Products purchased (*i.e.*, Neutrogena Naturals Purifying Facial Cleanser,  
 2 Purifying Pore Scrub, Face and Body Bar, Fresh Cleansing + Makeup Remover) and \$2 for each  
 3 of the moisturizer Products purchased (*i.e.*, Multi-Vitamin Nourishing Moisturizer, Multi-Vitamin  
 4 Nourishing Night Cream)).<sup>2</sup> Todzo Decl. Exh. 1, ¶ III.B.3.

5 Notice to the Class will be provided shortly after the Court’s preliminary approval and will  
 6 be achieved by several means, which Plaintiffs’ counsel and Neutrogena have selected as the most  
 7 effective means of reaching the proposed Class members. *Id.*, Exh. 1, ¶ VI.B. First, Neutrogena  
 8 will provide notice via e-mail or U.S mail to all Class members for whom it has contact  
 9 information, and will post relevant links on its Neutrogena Naturals website.<sup>3</sup> *Id.*, Exh, 1-D, ¶¶ 1,  
 10 8. Second, the Claim Administrator will publish a notice in *People* and *US Weekly* magazines and  
 11 in the *San Francisco Chronicle* newspaper. *Id.*, Exh, 1-D, ¶ 4. Third, press releases will be sent  
 12 to the PR Newswire service and to pertinent weblogs (a.k.a. “blogs”) covering beauty supplies,  
 13 cosmetics, and skin care issues. *Id.*, Exh, 1-D, ¶ 5. Fourth, internet and mobile phone  
 14 advertisements targeting potential Class members will be run on various media services. *Id.*, Exh,  
 15 1-D, ¶¶ 6-7. All notices will direct Class members to a settlement website and toll-free telephone  
 16 support system, which are to be set up by the Claim Administrator using Class funds. *Id.*, Exh, 1-  
 17 D, ¶¶ 2-3. The website will include a more detailed notice fully explaining the terms of the  
 18 settlement and all attendant Class member rights both in English and Spanish.<sup>4</sup> *Id.*, Exh. 1, ¶  
 19 VI.B.1; *see also id.*, Ex. 1-C & 1-E. No more than \$550,000 of the Claim Fund may be used to  
 20 reimburse those costs reasonably and actually incurred by the Claim Administrator in connection  
 21 with providing notice and administering claims. *Id.*, Exh. 1, ¶ III.B.2(a).

 Products (\$1 versus \$2) simply reflects the fact that the moisturizer Products are more expensive.

1 The Settlement Agreement allows no possibility of any Claim Fund monies reverting to  
2 Neutrogena. If the amounts ultimately paid on claims and expenses do not equal or exceed \$1.3  
3 million, the remainder of the Claim Fund shall be distributed to an appropriate non-profit or civic  
4 entity(ies) for use in a manner that the Court determines to be an appropriate vehicle to provide the  
5 next best use of compensation to Class members. *Id.*, Exh. 1, ¶ III.B.2(c).

6 **C. The Parties Will Stipulate To Class Certification For Settlement**  
7 **Purposes.**

8 Plaintiffs seek certification pursuant to Fed. R. Civ. P. 23(a), (b)(2), and (b)(3), and  
9 Neutrogena has agreed to stipulate to class certification solely for purposes of achieving  
10 settlement. Todzo Decl. Exh. 1, ¶ V. The putative settlement Class will comprise all persons or  
11 entities in the United States who purchased Neutrogena Naturals Purifying Facial Cleanser,  
12 Purifying Pore Scrub, Face and Body Bar, Fresh Cleansing + Makeup Remover, Multi-Vitamin  
13 Nourishing Moisturizer, or Multi-Vitamin Nourishing Night Cream from January 1, 2011 – *i.e.*,  
14 the approximate date when the Product line was initially launched – to the date notice to the Class  
15 is to be published. *Id.*

16 Class members will have until forty-five (45) days prior to the Final Approval Hearing to  
17 file any objections to the proposed settlement, to seek exclusions from the Class, or to file notices  
18 of intent to appear at the hearing. Todzo Decl. Exh. 1, ¶ VI.B.3. The parties will monitor and  
19 track those Class members seeking exclusion or objecting to the proposed settlement. *Id.*, Exh. 1,  
20 ¶ VI.D.

21 **D. Neutrogena Will Pay A Portion Of Plaintiffs' Reasonable**  
22 **Attorneys' Fees And Litigation Costs, And Service Awards To**  
23 **The Plaintiffs.**

24 Pursuant to the Settlement Agreement and following the Court's preliminary approval of  
25 the Stipulation of Settlement, Class Counsel will submit an application to the Court for an award  
26 of attorneys' fees and expenses not to exceed \$500,000, subject to the Court's approval. Todzo  
27 Decl. Exh. 1, ¶ VIII.A.2. Neutrogena will not oppose this application. *Id.* Any award of fees will  
28 in no way affect the amount disbursed as part of the Claim Fund. Todzo Decl. Exh. 1, ¶ VIII.A.1.

1 The Claim Fund disbursements may include a modest award to compensate the three  
 2 named Plaintiffs for their service as Class representatives, the application for which Neutrogena  
 3 agrees not to oppose. *Id.*, Exh. 1, ¶ VIII.B. The amount of these awards is not to exceed \$1,000  
 4 for Plaintiff Stephenson and \$500 each for Plaintiffs Haber and Tam. *Id.*

## 5 ARGUMENT

### 6 **I. THE COURT SHOULD GRANT PRELIMINARY APPROVAL 7 OF THE SETTLEMENT.**

8 The proposed settlement is fair and reasonable. The settlement provides substantial  
 9 benefits to the Class by requiring changes in Neutrogena’s labeling and marketing practices, and  
 10 by securing just compensation for Product purchases already made. The settlement accomplishes  
 11 this while avoiding both the uncertainty and the delay that would be associated with further  
 12 litigation. It represents a fair compromise of the parties’ respective positions in the litigation, and  
 13 enables each party to end the litigation, thus avoiding its costs and risks. Finally, the settlement  
 14 was reached through arm’s length negotiations as part of a supervised mediation process.  
 15 Plaintiffs’ counsel, which has significant experience in litigating class actions, supports the  
 16 resulting settlement as fair and as providing reasonable relief to the members of the Class.

#### 17 **A. The Applicable Legal Standard.**

18 A proposed settlement may be approved by the trial court if it is determined to be  
 19 “fundamentally fair, adequate, and reasonable.” *In re Mego Fin. Corp. Sec. Litig.*, 213 F.3d 454,  
 20 458 (9th Cir. 2000) (citing *Hanlon v. Chrysler Corp.*, 150 F.3d 1011, 1026 (9th Cir. 1998)).

21 Given that the full fairness and adequacy of a class settlement can only be assessed at the  
 22 final approval hearing, at the preliminary approval stage the Court “need only review the parties’  
 23 proposed settlement to determine whether it is within the permissible ‘range of possible judicial  
 24 approval’ and thus, whether the notice to the class and the scheduling of the formal fairness  
 25 hearing is appropriate.” *Williams v. Costco Wholesale Corp.*, 2010 WL 761122, at \*5 (S.D. Cal.  
 26 Mar. 4, 2010) (citing WILLIAM B. RUBENSTEIN ET AL., *NEWBERG ON CLASS ACTIONS*  
 27 § 11:25 (4th ed. 2002) (citations omitted)); *see also Wright v. Lucas Enters.*, 259 F.R.D. 468, 472  
 28 (E.D. Cal. 2009); *Alberto v. GMRI, Inc.*, 252 F.R.D. 652, 666 (E.D. Cal. 2008).

1 Preliminary approval of a settlement and notice to the proposed class is appropriate if “[1]  
2 the proposed settlement appears to be the product of serious, informed, noncollusive negotiations,  
3 [2] has no obvious deficiencies, [3] does not improperly grant preferential treatment to class  
4 representatives or segments of the class, and [4] falls with the range of possible approval....”  
5 *Williams*, 2010 WL 761122, at \*5 (brackets and ellipses in original) (quoting *Vasquez v. Coast*  
6 *Valley Roofing, Inc.*, 2009 WL 3857428, at \*7 (E.D. Cal. Nov. 17, 2009)). This settlement meets  
7 all of the above criteria.

8 **B. This Settlement Is The Product of Serious, Informed, And**  
9 **Arm’s-Length Negotiations.**

10 Arm’s-length negotiations conducted by competent counsel constitute *prima facie*  
11 evidence of fair settlements. *See M. Berenson Co. v. Faneuil Hall Marketplace*, 671 F. Supp. 819,  
12 822 (D. Mass. 1987) (“Where ... a proposed class settlement has been reached after meaningful  
13 discovery, after arm’s-length negotiation by capable counsel, it is presumptively fair.”).

14 The parties’ negotiations were adversarial and at arm’s length. *See Todzo Decl.* ¶ 2.  
15 Counsel for Plaintiffs have considerable experience in class action litigation in general, and with  
16 the legal and factual issues of this case in particular. *See id.*, ¶¶ 3-4, 11-13. Furthermore, although  
17 no formal discovery was conducted, Neutrogena did provide Plaintiffs with vital information  
18 pertaining to the legitimacy and scope of Plaintiffs’ claims, including sworn statements to  
19 Plaintiffs confirming information regarding Neutrogena’s Naturals products and the number of  
20 Naturals products sold to date. *See id.* ¶ 4; *see also, e.g., In re Mego*, 213 F.3d at 459 (“[I]n the  
21 context of class actions settlements, formal discovery is not a necessary ticket to the bargaining  
22 table where the parties have sufficient information to make an informed decision about  
23 settlement.”) (citation omitted). This sharing of information ensured sophisticated and meaningful  
24 settlement negotiations, which were conducted over several months, including a face-to-face  
25 meeting with members of Neutrogena’s internal legal team. *See Todzo Decl.* ¶ 2. In short, the  
26 parties were fully informed of all relevant facts at the time a settlement was reached.  
27  
28

**C. The Settlement Has No “Obvious Deficiencies” And Treats No Members Of The Class Preferentially.**

The settlement is fair in light of the status of the litigation, and treats Class members equitably. All potential future purchasers of the Products will receive the benefit of the injunctive relief provided for in the settlement, and all Class members who purchased the Products dating back to January 2011 will receive the benefit of the monetary relief provided for therein.<sup>5</sup> The settlement’s notice provisions, which are detailed and comprehensive and which will be administered by a qualified third party, will help to ensure that such purchasers will actually recoup their monetary losses. *See Alberto*, 252 F.R.D. at 666-67 (satisfactory notice provisions weigh in favor of preliminary approval). Moreover, the substantial injunctive and monetary relief secured by the settlement is quite fair in light of the significant hurdles faced by Plaintiffs and the Class going forward: Neutrogena vigorously disputes that the Class would be able to prove liability, certify a class, or be entitled to injunctive relief or monetary damages.

Although Plaintiffs believe that they could establish liability were the case to go to trial, this is hardly an easy win. The term “natural” as used on cosmetic products has not been conclusively defined by state or federal regulatory agencies. In the absence of agency guidance, Plaintiffs would face the hurdle of establishing that Neutrogena’s use of the term in labeling and marketing its Products is deceptive to a reasonable consumer based on more equivocal conceptions of the term. Notably, other plaintiffs have failed in bringing similar lawsuits alleging deception by so-called “natural” products.

Furthermore, Plaintiffs note that this Court already granted in part Neutrogena’s motion to dismiss on Article III standing grounds, which significantly pared down the operative claims in the case. Although Plaintiffs believe that they have remedied these infirmities in the allegations of the Second Amended Complaint, the sufficiency of these allegations has yet to be challenged by

---

<sup>5</sup> The service awards to the three Plaintiff Class representatives, which are not to exceed a total of \$2,000, are far less than service awards approved by other courts. *See, e.g., Williams*, 2010 WL 761122, at \*2, \*6 (\$5,000 service award to single named plaintiff “does not appear facially unreasonable”); *see also* Todzo Decl. ¶ 10 (detailing the services provided).





1 so forth – this issue, no doubt, would form a central dispute in any damages calculation at trial.  
2 Looking past these ambiguities, however, the \$1.3 million monetary recovery represents a  
3 substantial percentage of what Plaintiffs believe to be their best case scenario for recovery at trial.  
4 The injunctive relief component of the settlement – which cannot be readily monetized, but which  
5 has tremendous value to consumers – only enhances the legitimacy of this recovery.

6       The reasonableness of the settlement is further underscored by the fact that it was reached  
7 only after participation in formal mediation before a qualified, neutral mediator. *See Alberto*, 252  
8 F.R.D. at 666 (brokering of settlement by qualified mediator weighs in favor of preliminary  
9 approval of settlement by court). Here, the parties employed the Honorable Edward A. Panelli, a  
10 former Justice of the California Supreme Court with decades of experience in the resolution of  
11 complex business litigation, including class actions and products liability cases, as a mediator. *See*  
12 *Todzo Decl.* ¶ 2 & Exh. 2.

13       Moreover, the fee award sought by Plaintiffs, which will be subject to further review by  
14 this Court at the final settlement approval stage, is well within the range of possible approval. *See*  
15 *Todzo Decl.* ¶ 11. This is especially true given the centrality of the injunctive relief component to  
16 the overall settlement. *See generally* Committee Notes to 2003 Amendments to Fed. R. Civ. P.  
17 23(h) (“[I]t is important to recognize that in some class actions the monetary relief obtained is not  
18 the sole determinant of an appropriate attorney fees award.”) (citing *Blanchard v. Bergeron*, 489  
19 U.S. 87, 95 (1989) (cautioning against an “undesirable emphasis” on “the importance of the  
20 recovery of damages in civil rights litigation” that might “shortchange efforts to seek effective  
21 injunctive or declaratory relief”).

22       For all of these reasons, preliminary approval of the settlement should be granted.

23                   **II. PROVISIONAL CERTIFICATION OF THE SETTLEMENT CLASS**  
24                   **IS APPROPRIATE.**

25       For settlement purposes only, Plaintiffs request that the Court provisionally certify the  
26 settlement Class proposed below pursuant to Rule 23 of the Federal Rules of Civil Procedure.

27

28

1 Provisional Class certification is appropriate in part because Neutrogena consents to Class  
 2 certification solely in the context of this settlement.<sup>6</sup> See Todzo Decl. Exh. 1, ¶ V. See also  
 3 generally The Rutter Group, *California Practice Guide: Federal Civil Procedure Before Trial*  
 4 (2012), Ch. 10-C at § 10:787 (noting that courts generally permit parties to stipulate that a defined  
 5 class be conditionally certified for settlement purposes because it facilitates settlement).

6 Because the parties have reached agreement regarding Class certification in the context of  
 7 this settlement, the Court may enter an order provisionally certifying the Class for settlement  
 8 purposes. See, e.g., *Alvarado Partners, L.P. v. Mehta*, 723 F. Supp. 540, 546 (D.C. Colo. 1989)  
 9 (holding that conditional class certification for settlement purposes may be ordered in appropriate  
 10 cases to foster such benefits as early settlement and reduced attorneys fees and costs). This will  
 11 allow notice of the proposed settlement to issue, so Class members can be informed of the  
 12 existence and terms of the proposed settlement, of their right to be heard on its fairness, of their  
 13 right to opt out, and of the date, time and place of the fairness hearing. See Federal Judicial  
 14 Center, *Manual for Complex Litigation* (4th ed. 2004) at §§ 21.632, 21.633.

15 Plaintiffs seek certification of a settlement Class defined as follows:

16 All persons or entities in the United States who purchased  
 17 Neutrogena Naturals Purifying Facial Cleanser, Purifying Pore  
 18 Scrub, Face and Body Bar, Fresh Cleansing + Makeup Remover,  
 19 Multi-Vitamin Nourishing Moisturizer, or Multi-Vitamin  
 Nourishing Night Cream from January 1, 2011, to the date notice  
 to the Class is to be published

20 **A. The Criteria For Class Certification Under Rule 23(a) Are Satisfied.**

21 To merit class certification under Rule 23(a), Plaintiffs must show that: (1) the class is so  
 22 numerous that joinder is impracticable; (2) questions of law or fact are common to the class;  
 23 (3) the claims of the representative Plaintiffs are typical of the claims of the class; and (4) the class

---

25 <sup>6</sup> Neutrogena's agreement to certification of a tentative settlement Class "is conditional and  
 26 without prejudice to [its] rights to later oppose class certification for trial purposes if the proposed  
 27 settlement is terminated or not finally approved." *Browning v. Yahoo! Inc.*, 2006 WL 3826714, at  
 \*4 (N.D. Cal. Dec. 27, 2006).

1 representatives will fairly and adequately protect the interests of the class. Each of these criteria is  
2 met here.

3 **1. Joinder Of All Members Is Impracticable.**

4 A class must be “so numerous that joinder of all members is impracticable.” Fed. R. Civ.  
5 P. 23(a)(1). Often, a large number of class members by itself establishes the impracticability of  
6 joining them as plaintiffs. *See Jordan v. County of Los Angeles*, 669 F.2d 1311, 1319 (9th Cir.  
7 1982), *vacated on other grounds*, 459 U.S. 810 (1982). Impracticability does not mean  
8 impossibility. *See, e.g., Immigrant Assistance Project of Los Angeles County Fed’n of Labor v.*  
9 *I.N.S.*, 306 F.3d 842, 869 (9th Cir. 2002) (noting that classes numbering 39, 64, and 71 met  
10 numerosity criterion); *Delarosa v. Boiron, Inc.*, 275 F.R.D. 582, 587 (C.D. Cal. 2011) (“[A]s a  
11 general rule, classes of forty or more are considered sufficiently numerous.”) (citation omitted).

12 Extrapolating from sales information provided by Neutrogena in settlement discussions,  
13 the number of persons who purchased the Products at issue is in the thousands. Because joinder of  
14 all of these individuals is impractical, if not entirely impossible, the numerosity requirement is  
15 satisfied.

16 **2. Common Issues Of Law And Fact Exist.**

17 This test for common questions of law and fact is “qualitative rather than quantitative –  
18 one significant issue common to the class may be sufficient to warrant certification.” *Dukes v.*  
19 *Wal-Mart, Inc.*, 509 F.3d 1168, 1177 (9th Cir. 2007). Here, “the class is united by a common  
20 interest in determining whether a defendant’s course of conduct is in its broad outlines  
21 actionable.” *Blackie v. Barrack*, 524 F.2d 891, 902 (9th Cir. 1975). Neutrogena utilizes  
22 advertisements and packaging that include uniform representations that the products are “natural”  
23 and contain no petrochemicals, which are allegedly false and misleading and violate the UCL and  
24 CLRA. These representations misled Plaintiffs and the other members of the Class, and  
25 Neutrogena breached uniform warranties that were made to Plaintiffs and the other members of  
26 the Class. Thus, the commonality requirement is satisfied. *See Zeisel v. Diamond Foods, Inc.*,  
27 2011 WL 2221113, at \*7 (N.D. Cal. June 7, 2011) (commonality met where “class was exposed to

28

1 the same misleading and misbranded labels”); *Chavez v. Blue Sky Natural Beverage Co.*, 268  
 2 F.R.D. 365, 377 (N.D. Cal. 2010) (commonality met where common issue was “whether the  
 3 [product] packaging and marketing materials are unlawful, unfair, deceptive or misleading to a  
 4 reasonable consumer”); *Delarosa*, 275 F.R.D. at 589 (commonality met where “Plaintiff alleges a  
 5 single misrepresentation [on a product’s packaging] that was made identically to all potential class  
 6 members”); *Bjustrom v. Trust One Mgmt. Corp.*, 199 F.R.D. 346, 348 (W.D. Wash. 2001)  
 7 (commonality met where the claims arose from “a standard course of conduct which adversely  
 8 affects a group of individuals and gives rise to a claim for relief”).

### 9 **3. The Named Plaintiffs’ Claims Are Typical Of Class** 10 **Claims.**

11 Rule 23(a)(3) requires “the claims and defenses of the representative parties [to be] typical  
 12 of the claims or defenses of the class.” Fed. R. Civ. P. 23(a)(3). Representative claims are typical  
 13 if they are “reasonably coextensive with those of the absent class members; they need not be  
 14 substantially identical.” *Dukes*, 509 F.3d at 1184 (quoting *Hanlon*, 150 F.3d at 1020). Where the  
 15 class representatives’ interests align with the interests of the class, then the pursuit of the class  
 16 representatives’ individual interests necessarily advances those interests of the class. “[A] named  
 17 plaintiff’s claim is typical if it stems from the same event, practice or course of conduct ... and is  
 18 based upon the same legal or remedial theory.” *Jordan*, 669 F.2d at 1321; *see also Hanlon*, 150  
 19 F.3d at 1019-20 (“[t]he existence of shared legal issues with divergent factual predicates is  
 20 sufficient, as is a common core of salient facts coupled with disparate legal remedies within the  
 21 class”); *Lozano v. AT & T Wireless Servs., Inc.*, 504 F.3d 718, 734 (9th Cir. 2007) (“Under Rule  
 22 23(a)(3), it is not necessary that all class members suffer the same injury as the class  
 23 representative.”).

24 Here, Plaintiffs’ and Class members’ claims stem from the same underlying wrongful  
 25 conduct – namely, they purchased Defendant’s Neutrogena Naturals personal products based on  
 26 the false and misleading representation that the Products are “natural” and free of petrochemicals.  
 27 Thus, there is a “sufficient nexus” between Plaintiffs’ claims and those of the Class members to  
 28 satisfy the typicality requirement. *See O’Donovan v. CashCall, Inc.*, 278 F.R.D. 479, 491-92

1 (N.D. Cal. 2011); *Zeisel*, 2011 WL 2221113, at \*8 (typicality met where plaintiff’s claims relating  
 2 to allegedly false health-related statements on product labels were “reasonably co-extensive with  
 3 those of absent class members,” notwithstanding particularities of class representative’s “specific  
 4 medical condition”); *Chavez*, 268 F.R.D. at 378 (typicality met where defendant made  
 5 “substantially the same misrepresentation” on several different beverage products, even where  
 6 allegedly false statements were “worded in several variations” and where “plaintiff did not buy  
 7 each product in [defendant’s] beverage line”).

8 **4. The Named Plaintiffs And Their Counsel Adequately**  
 9 **Represent The Proposed Class.**

10 The adequacy of representation requirement is satisfied if (1) the proposed representative  
 11 plaintiff does not have conflicts with the proposed class, and (2) the plaintiff is represented by  
 12 qualified and competent counsel. *See Dukes*, 509 F.3d at 1185.

13 Because Plaintiffs and Class members have been allegedly injured in the same manner and  
 14 seek relief for the same claims, their interests are coextensive. *See O’Donovan*, 278 F.R.D. at 492  
 15 (class representative fairly and adequately represents class where “their claims are reflective of  
 16 those of the putative class members’ and the relief they seek is identical to that sought for the  
 17 Classes.”). Plaintiffs’ counsel are qualified and experienced in certifying, litigating, trying,  
 18 settling, and administering nationwide class actions similar to this case. *See Todzo Decl.* ¶¶ 12-13  
 19 & Exh. 3-4. Plaintiffs and their counsel readily satisfy the requirements of Rule 23(a)(4).

20 **B. The Proposed Settlement Class Meets The Requirements Of**  
 21 **Rule 23(b)(2) and 23(b)(3).**

22 Class certification is appropriate under Rule 23(b)(2). Neutrogena has acted on grounds  
 23 that apply generally to the Class, such that final injunctive relief is appropriate respecting the Class  
 24 as a whole. Neutrogena utilizes product packaging and advertising campaigns which include  
 25 uniform misrepresentations that misled Plaintiffs and were and are likely to mislead the other  
 26 members of the Class. Plaintiffs seek to enjoin Defendant’s misrepresentations and injunctive  
 27 relief will benefit them, the Class, and future purchasers of Defendant’s personal care products.  
 28 *See Delarosa*, 275 F.R.D. at 592 (certification under Rule 23(b)(2) appropriate where “an

1 injunction prohibiting Defendant from selling [product] with the misleading information would  
2 ‘provide relief to each member of the class.’”).

3 In addition, class certification is appropriate under Rule 23(b)(3) because common  
4 questions of law and fact substantially predominate over any questions that may affect only  
5 individual members of the Class. Where, as here, “common questions present a significant aspect  
6 of the case and they can be resolved for all members of the class in a single adjudication, there is  
7 clear justification for handling the dispute on a representative rather than on an individual basis.”  
8 *Hanlon*, 150 F.3d at 1022. The overarching legal and factual questions in this case – which do not  
9 vary among Class members and which may be determined without reference to the individual  
10 circumstances of any Class member – include, but are not limited to:

- 11 • whether Defendant labels, advertises and markets its Neutrogena Naturals personal  
12 care products by representing that the products are “natural”;
- 13 • whether such Products are indeed natural;
- 14 • whether Defendant’s representations that the Products are natural is unethical,  
15 oppressive, unscrupulous, and/or substantially injurious to consumers;
- 16 • whether Defendant’s conduct in advertising and marketing the Products constitutes  
17 a violation of the FAL;
- 18 • whether Defendant’s conduct in advertising and marketing the Products constitutes  
19 a violation of the CLRA;
- 20 • whether Defendant’s conduct constitutes fraudulent, unfair, or unlawful conduct as  
21 defined by the UCL;
- 22 • whether Plaintiff and Class members are entitled to injunctive and other equitable  
23 relief based on Defendant’s violations of the FAL, CLRA, and UCL;
- 24 • whether Defendant’s representations concerning the Products constitute express  
25 warranties with regard to the Products pursuant to California Civil Code § 2313;  
26 and
- 27 • whether Plaintiffs and the Class are entitled to damages resulting from Defendant’s  
28 breach of the express warranties made regarding the Products.

25 As this list demonstrates, each of Plaintiffs’ contentions can be proven with “generalized  
26 evidence ... on a class-wide basis.” *O’Donovan*, 278 F.R.D. at 493. In other words, a  
27 determination that Neutrogena misrepresented its cosmetic products as “natural” to Plaintiffs will  
28 necessarily determine whether Neutrogena similarly misrepresented its products to all Class

1 members. *See Delarosa*, 275 F.R.D. at 594. Because “[a] common nucleus of facts and potential  
2 legal remedies dominates this litigation,” Rule 23(b)(3) is satisfied here. *Hanlon*, 150 F.3d at  
3 1022.

4 Furthermore, Fed. R. Civ. P. 23(b)(3) allows the certification of a nationwide class on the  
5 facts of this case. As several courts have recognized, the Ninth Circuit in *Mazza* did not announce  
6 a *per se* rule that California law cannot be applied to consumers nationwide. *See, e.g., In re POM*  
7 *Wonderful LLC Mktg. & Sales Practices Litig.*, 2012 WL 4490860, at \*3 (C.D. Cal. Sept. 28,  
8 2012); *Bruno*, 280 F.R.D. at 546–47. Indeed, this Court has so found in a similar case involving  
9 allegations that Ben & Jerry’s falsely labeled its ice cream products as natural. *See* March 30,  
10 2012 Order Granting Preliminary Approval of Proposed Class Action Settlement in *Astiana v. Ben*  
11 *& Jerry’s Homemade, Inc.*, Case No. 10 Civ. 4387-PJH. Rather, as *Mazza* itself did, courts look  
12 to California traditional choice-of-law rules to determine whether California law should apply to  
13 consumers in other states. *See* 666 F.3d at 589. “Under that framework, once a plaintiff shows  
14 that California has significant contact with each class member’s claim, and that application of  
15 California would therefore be constitutional, the burden shifts to the defendant to show that some  
16 foreign law, rather than California law, should apply.” *POM Wonderful*, 2012 WL 4490860, at  
17 \*2. Here, Neutrogena is headquartered in California and the marketing strategies about which  
18 Plaintiffs complain were developed in California. Moreover, each of the Product labels indicates  
19 that the Product is “Dist[ributed] by Neutrogena Corporation, Los Angeles, CA.” There is no  
20 indication that the laws of other states are materially different with respect to regulating the types  
21 of representations Neutrogena makes about its Products. *See, e.g., Bruno*, 280 F.R.D. at 550  
22 (finding that no conflict had been shown between California’s consumer protection laws and those  
23 of other states with respect to claims regarding the effectiveness of dietary supplements). And,  
24 even if there were such a conflict, it is plain that California’s interests would be more impaired  
25 were the laws of another state applied to the California-based actions of a California company. In  
26 sum, the certification of a nationwide class is wholly appropriate in this case.

1                                   **III. THE PROPOSED CLASS NOTICE SATISFIES THE**  
2                                   **REQUIREMENTS OF DUE PROCESS.**

3                   “Rule 23(e)(1)(B) requires the court to ‘direct notice in a reasonable manner to all class  
4 members who would be bound by a proposed settlement, voluntary dismissal, or compromise’  
5 regardless of whether the class was certified under Rule 23(b)(1), (b)(2), or (b)(3).” *Manual for*  
6 *Complex Litig.* at § 21.312. The Settlement Agreement provides for notice that easily satisfies  
7 Rule 23 and due process considerations.

8                                   **A. The Method Of Notice Proposed Is Appropriate.**

9                   The method proposed for providing notice to Class members is “reasonable” and should be  
10 approved. Notice to the Class will be achieved shortly after entry of the Preliminary Approval  
11 Order, in at least four ways. First, e-mail or U.S. Mail notice will be sent to the most recent e-mail  
12 or U.S. Mail address of each settlement Class member according to Neutrogena’s records.  
13 Second, a notice will be published in two magazines with nationwide circulations in the millions –  
14 *People* and *US Weekly* – and in the *San Francisco Chronicle* newspaper. Third, press releases will  
15 be sent to the PR Newswire service and to topically relevant blogs covering beauty supplies,  
16 cosmetics, and skin care issues. Fourth, internet and mobile phone advertisements targeting  
17 potential Class members will be run on various media services. The Notice will be provided to  
18 Class members so that they have sufficient time to decide whether to participate in the settlement,  
19 object, or opt out. Courts routinely find that far less comprehensive notice programs meet the  
20 requirements of due process and Rule 23. *See, e.g., In re Portal Software, Inc. Sec. Litig.*, 2007  
21 WL 1991529, at \*7 (N.D. Cal. June 30, 2007) (notice adequate via U.S. mail and publication in  
22 national edition of single periodical); *In re Enron Sec. & ERISA Litig.*, 2003 WL 22494413, at \*3  
23 (S.D. Tex. July 24, 2003) (notice adequate via U.S. mail and publication in two daily newspapers).

24                                   **B. The Contents Of The Proposed Notice Are Adequate.**

25                   Rule 23 requires that notice of a settlement be “the best notice practicable under the  
26 circumstances, including individual notice to all members who can be identified through  
27 reasonable effort.” Fed. R. Civ. P. 23(c)(2)(B). The contents of the notice to class members “is  
28 satisfactory if it ‘generally describes the terms of the settlement in sufficient detail to alert those

1 with adverse viewpoints to investigate and to come forward and be heard.” *Rodriguez v. West*  
2 *Publ’g Corp.*, 563 F.3d 948, 962 (9th Cir. 2009) (quoting *Churchill Vill., LLC v. General Elec.*,  
3 361 F.3d 566, 575 (9th Cir. 2004)).

4 Here, the proposed notice forms provide this “sufficient detail.” *See* Todzo Decl. Exh. 1-C  
5 & 1-E. Together, they define the Class, explain all Class member rights, releases, and applicable  
6 deadlines, and describe in detail the injunctive and monetary terms of the settlement, including the  
7 procedures for allocating and distributing settlement funds. They plainly indicate the time and  
8 place of the hearing to consider approval of the settlement, and the method for objecting to or  
9 opting out of the settlement. They detail the provisions for payment of attorneys fees and service  
10 awards to the class representatives, and provide contact information for the putative Class  
11 Counsel. This comports with settlement notices upheld in other cases. *See, e.g., In re Wells*  
12 *Fargo Loan Processor Overtime Pay Litig.*, 2011 WL 3352460, at \*4 (N.D. Cal. Aug. 2, 2011)  
13 (notice adequate where “[i]t disclosed all material elements of the settlement, including class  
14 members’ release of claims, their ability to opt out or object to the settlement, the amount of  
15 incentive awards and attorneys’ fees sought, and estimates of the award members could expect to  
16 receive.”). *See generally Rodriguez*, 563 F.3d at 962-63 (because “[s]ettlement notices are  
17 supposed to present information about a proposed settlement neutrally, simply, and  
18 understandably,” they need not “detail the content of objections, or analyze the expected value” of  
19 fully litigating the case).

20 **IV. SCHEDULING A FINAL APPROVAL HEARING IS**  
21 **APPROPRIATE.**

22 The last step in the settlement approval process is a final fairness hearing at which the  
23 Court may hear all evidence and argument necessary to make the settlement evaluation.  
24 Proponents of the settlement may explain the terms and conditions of the settlement and offer  
25 argument in support of final approval. In addition, settlement class members, or their counsel,  
26 may be heard in support of or in opposition to the Settlement Agreement. The Court will  
27 determine after the Final Approval Hearing whether the settlement should be approved, and  
28 whether to enter a final order and judgment under Rule 23(e). Plaintiffs request that the Court set

1 a date for the final fairness hearing approximately ninety (90) days after entry of the Preliminary  
2 Approval Order.

3 **CONCLUSION**

4 For all of the foregoing reasons, Plaintiffs respectfully request that the Court grant  
5 preliminary approval to the proposed settlement, provisionally certify the proposed settlement  
6 Class, appoint as “Class Counsel” the Lexington Law Group and Scott + Scott LLP, approve the  
7 proposed notice plan, and schedule a formal fairness hearing on final settlement approval  
8 approximately ninety (90) days after entry of the Preliminary Approval Order.

1 WHEREAS, Plaintiffs<sup>1</sup> in the action entitled *Stephenson v. Neutrogena Corporation*, No. C  
2 12-00426 PJH (N.D. California) and Neutrogena Corporation have entered into a Stipulation of  
3 Settlement, filed December 20, 2012, after arms-length settlement discussions;

4 AND, WHEREAS, the Court has received and considered the Stipulation, including the  
5 accompanying exhibits;

6 AND, WHEREAS, the Parties have made an application for an order preliminarily approving  
7 the settlement of this Action, and for its dismissal with prejudice upon the terms and conditions set  
8 forth in the Stipulation;

9 AND, WHEREAS, the Court has reviewed the Parties' application for such order, and has  
10 found good cause for same.

11 NOW, THEREFORE, IT IS HEREBY ORDERED:

12 **A. The Settlement Class Is Conditionally Certified**

13 1. Pursuant to Federal Rule of Civil Procedure 23, and for settlement purposes only, the  
14 Court hereby certifies the following Class:

15 All individuals in the United States who purchased Neutrogena Naturals Purifying  
16 Facial Cleanser, Purifying Pore Scrub, Face and Body Bar, Fresh Cleansing +  
17 Makeup Remover, Multi-Vitamin Nourishing Moisturizer, or Multi-Vitamin  
18 Nourishing Night Cream from January 1, 2011 until [REDACTED] (the date notice of this  
19 Settlement to the Class is first published). Specifically excluded from the Class are  
20 (a) Defendant, (b) the officers, directors, or employees of Defendant and their  
21 immediate family, (c) any entity in which Defendant has a controlling interest, (d)  
22 any affiliate, legal representative, heir, or assign of Defendant, (e) all federal court  
23 judges who have presided over this Action and their immediate family; (b) all  
24 persons who have submitted a valid request for exclusion from the Class; and (d)  
25 those who purchased the Neutrogena Naturals products listed above for the purpose  
26 of resale.

22 2. With respect to the Class and for settlement purposes only, the Court preliminarily  
23 finds the prerequisites for a class action under Federal Rules of Civil Procedure 23(a) and (b)(3)  
24 have been met, including: (a) numerosity; (b) commonality; (c) typicality; (d) adequacy of the class

1 representatives and Class Counsel; (e) predominance of common questions of fact and law among  
2 the Class for purposes of settlement; and (f) superiority.

3 3. Pursuant to Federal Rule of Civil Procedure 23, the Court hereby appoints the  
4 Plaintiffs in the Action, Desiree Stephenson, Marni Haber, and Karva Tam, as the class  
5 representatives.

6 4. Having considered the factors set forth in Federal Rule of Civil Procedure 23(g)(1),  
7 the Court hereby appoints the law firms of Scott + Scott LLP and Lexington Law Group, as Class  
8 Counsel.

9 **B. The Stipulation Is Preliminarily Approved and Final Approval  
10 Schedule Set**

11 5. The Court hereby preliminarily approves the Stipulation and the terms and conditions  
12 of settlement set forth therein, subject to further consideration at the Final Approval Hearing  
13 described below.

14 6. The Court has conducted a preliminary assessment of the fairness, reasonableness,  
15 and adequacy of the Stipulation, and hereby finds that the settlement falls within the range of  
16 reasonableness meriting possible final approval. The Court therefore preliminarily approves the  
17 proposed settlement as set forth in the Stipulation.

18 7. Pursuant to Federal Rule of Civil Procedure 23(e), the Court will hold a Final  
19 Approval Hearing on \_\_\_\_\_, at \_\_\_\_\_ a.m./p.m., in the Courtroom of the Honorable  
20 Phyllis J. Hamilton, United States District Court for the Northern District of California, 1301 Clay  
21 Street, Oakland, CA 94612, for the following purposes:

22 (a) finally determining whether the Class meets all applicable requirements of  
23 Federal Rule of Civil Procedure 23 and, thus, the Class should be certified for purposes of  
24 effectuating the settlement;

25 (b) determining whether the proposed settlement of the Action on the terms and  
26 conditions provided for in the Stipulation is fair, reasonable and adequate and should be approved by  
27 the Court;

1 (c) considering the application of Class Counsel for an award of attorneys' fees  
2 and reimbursement of expenses, as provided for under the Stipulation;

3 (d) considering the applications of Plaintiffs for class representative incentive  
4 awards, as provided for under the Stipulation;

5 (e) considering whether the Court should enter the [Proposed] Final Settlement  
6 Order and Judgment;

7 (f) considering whether the release of the Released Claims as set forth in the  
8 Stipulation should be provided; and

9 (g) ruling upon such other matters as the Court may deem just and appropriate.

10 8. The Court may adjourn the Final Approval Hearing and later reconvene such hearing  
11 without further notice to Class Members.

12 9. The Parties may further modify the Stipulation prior to the Final Approval Hearing so  
13 long as such modifications do not materially change the terms of the settlement provided thereunder.  
14 The Court may approve the Stipulation with such modifications as may be agreed to by the Parties, if  
15 appropriate, without further notice to Class Members.

16 10. All papers in support of the settlement and any application for an award of attorneys'  
17 fees and expenses and/or class representative incentive awards must be filed with the Court and  
18 served at least seven days prior to the Final Approval Hearing.

19 **C. The Court Approves the Form and Method of Class Notice**

20 11. The Court approves, as to form and content, the proposed Publication Notice and  
21 Class Notice (collectively the "Notice"), which are Exhibits C and E, respectively, to the Stipulation.

22 12. The Court finds that the distribution of Notice substantially in the manner and form  
23 set forth in the Stipulation meets the requirements of Federal Rule of Civil Procedure 23 and due  
24 process, is the best notice practicable under the circumstances, and shall constitute due and sufficient  
25 notice to all persons entitled thereto.

26 13. The Court approves the designation of the Garden City Group to serve as the Court-  
27 appointed Claim Administrator for the settlement. The Claim Administrator shall cause the



1 Publication Notice to be published, disseminate Class Notice, and supervise and carry out the notice  
2 procedure, the processing of claims, and other administrative functions, and shall respond to Class  
3 Member inquiries, as set forth in the Stipulation and this Order under the direction and supervision  
4 of the Court.

5 14. The Court directs the Claim Administrator to establish a Settlement Website, making  
6 available copies of this Order, Class Notice, Claim Forms that may be downloaded and submitted  
7 online, by mail, or by facsimile, the Stipulation and all Exhibits thereto, a toll-free hotline, and such  
8 other information as may be of assistance to Class Members or required under the Stipulation. The  
9 Class Notice and Claim Forms shall be made available to Class Members through the Settlement  
10 Website on the date notice is first published and continuously thereafter through the Effective Date  
11 (and on the websites of Class Counsel at their options during the same period).

12 15. The Claim Administrator is ordered to complete publication of the Publication Notice  
13 on or about 90 days before the Final Approval Hearing.

14 16. The costs of Notice, processing of claims of Class Members, creating and maintaining  
15 the Settlement Website, and all other Claim Administrator and Notice expenses shall be paid by  
16 Defendant in accordance with the applicable provisions of the Stipulation.

17 **D. Procedure for Class Members to Participate in the Settlement**

18 17. The Court approves the Parties' proposed Claim Form. Any Class Member who  
19 wishes to participate in the settlement shall complete a Claim Form in accordance with the  
20 instructions contained therein and submit it to the Claim Administrator no later than 5 days after the  
21 date of the Final Approval Hearing, which date will be specifically identified in the Claim Form.  
22 Such deadline may be further extended without notice to the Class by written agreement of the  
23 Parties.

24 18. The Claim Administrator shall have the authority to accept or reject claims in  
25 accordance with the Stipulation, including the Claims Administration Protocols.

11 25. All objections must include the name, address, and telephone number of the objecting  
12 Class Member, an affirmation that they purchased Neutrogena Naturals Purifying Facial Cleanser,  
13 Purifying Pore Scrub, Face and Body Bar, Fresh Cleansing + Makeup Remover, Multi-Vitamin  
14 Nourishing Moisturizer, or Multi-Vitamin Nourishing Night Cream during the Class Period, an  
15 explanation of the objection, and the submitting party's signature. All objections must also include a  
16 reference to *Stephenson v. Neutrogena Corporation*, No. C 12-00426 PJH (N.D. California). Each  
17 Class Member submitting an objection must state whether he or she (or his or her attorney) intends

19 26. Attendance at the Final Approval Hearing is not necessary; however, any Class

22 awards are required to provide written notice of their intention to appear at the Final Approval  
23 Hearing no later than 45 days prior to the date of the Final Approval Hearing, which date will be  
24 specifically identified in the Class Notice. Class Members who do not oppose the settlement, the  
25 applications for attorneys' fees and expenses, or class representative incentive awards need not take  
26 any action to indicate their approval. A Class Member's failure to submit a written objection in
