#### JOINT MOTION TO ADMINISTRATIVELY CLOSE PROCEEDINGS

Plaintiff, Brian Calvert and Defendant, Walgreen Co. (together the "Parties"), by and through their respective undersigned counsel, hereby jointly move this Court to administratively close the above-captioned matter.

This Court previously indicated that it would administratively close this matter upon the consent of the Parties, and the Parties have concluded that it is in their best interest and the interest of the Court that this matter be administratively closed at this time. All Parties, including Plaintiff in this action and his counsel, have agreed to a revised global settlement in this matter, and the motion for preliminary approval of that settlement was submitted to the Honorable Vincent L. Briccetti in the Southern District of New York on July 16, 2014 (before whom three earlier-filed cases are pending that are also part of the settlement). The hearing on that motion for preliminary approval is scheduled for August 1, 2014. Thus, administrative closure will serve the interests of the parties and conserve the resources of this Court.

As reflected in the attached proposed order, the Parties respectfully request a six-month time frame immediately following the Court's entry of an order of administrative closure during which time either party may petition this Court to reopen this matter. The Parties agree that upon

the expiration of that six months period, the order of administrative closure will automatically expire and mature into a final order of dismissal.
