Pursuant to Fed. R. Civ. P. 41(a)(1)(A)(ii), Plaintiff Carol Maher and Defendants Sempris, LLC and Northside Communications, LLC, by and through their undersigned attorneys, hereby file this Joint Stipulation of Dismissal with Prejudice and state as follows:

1. After having reviewed and conducted an analysis of the discovery exchanged in this action, Plaintiff has determined that she is no longer interested in proceeding with her individual claims in this action, and also to not move for class certification.

2. The Parties agree that each party shall bear her or its own costs and attorneys' fees in this action. Other than this agreement regarding fees and costs in this action, there are no agreements between the parties concerning the claims asserted in this action, and, specifically, no consideration has flowed from Defendants to plaintiff or her counsel in exchange for this dismissal with prejudice.

3. With the filing of this stipulation, the parties agree that this action is dismissed "without a court order" and with prejudice under Rule 41(a)(1).
