23 This Court has consolidated the actions filed by Plaintiffs Shuxin Li, Julia  
24 Leung, Haiyuan Zhao, Yu Hu, and Hongyan Liu (the “Li Plaintiffs”) with the putative  
25 class action filed by Plaintiffs Yunxia Wang, Fengqin Zu, and Qun Zu (the “Wang  
26 Plaintiffs”). The Li Plaintiffs desire to support and participate in the Wang Plaintiffs’  
27 class action as putative class members, without separately litigating the Li Plaintiffs’

1 individual claims. To that end, Plaintiffs Shuxin Li, Julia Leung, Haiyuan Zhao, Yu  
2 Hu, and Hongyan Liu, hereby dismiss their complaints against all defendants, without  
3 prejudice.

4 This dismissal is made pursuant to Rule 41(a) of the Federal Rules of Civil
