CLASS ACTION COMPLAINT AND DEMAND FOR JURY TRIAL

COMES NOW, Plaintiff KRIKOR "GREGORY" NALBANTIAN ("Plaintiff"),
individually, and on behalf of all other members of the general public similarly situated, and
alleges, based on information and belief, as follows:

INTRODUCTION

1. This case is brought on behalf of all California based consumers who have
purchased and/or consumed any menu item that purports to contain "Kobe" beef from or at a
restaurant owned, managed or operated by Defendants within the State of California including,
but not limited to, the "Ultimate Kobe Burger" or "Kobe Beef Burger." (See EXHIBIT 1.)

2. "Kobe" beef is only available from Japan. The term "Kobe" signifies that the
beef comes from the "Wagyu" bloodline of cattle which are isolated in the Kobe region of Japan,
and further signifies that the beef comes from cattle slaughtered within the Kobe region of Japan.
The United States Department of Agriculture has banned importation of beef and cattle from
Japan, including "Kobe" beef and "Wagyu" cattle, since approximately May 2010 to prevent the
spread of Foot and Mouth Disease as well as Bovine Spongiform Encephalopathy. (9 C.F.R.
§94.1; 9 C.F.R. §94.18(a)(1)). The menu items at BARNEY'S WORLDWIDE, INC. owned,
managed or operated restaurants that purport to contain "Kobe" beef do not actually contain
"Kobe" beef because the importation of "Kobe" beef to the United States is prohibited. In
addition, the importation of "Wagyu" cattle to the United States is prohibited.

3. Due to false and deceptive business practices and representations, Defendant
BARNEY'S WORLDWIDE, INC. has misled the general public into believing that the menu
items which purport to contain "Kobe" beef offered at BARNEY'S WORLDWIDE, INC.
owned, managed or operated restaurants do in fact contain "Kobe" beef.

4. Defendant BARNEY'S WORLDWIDE, INC. owns, manages or operates
restaurants employing the trade name "Barney's Beanery." The menu items at BARNEY'S
WORLDWIDE, INC. owned, managed or operated restaurants advertised as "Kobe" beef or
represented to be "Kobe" beef on the restaurant or on-line menus will hereinafter be referred to
as the "Subject Food Product."

1 5. Since it began operating restaurants in the State of California to the present,
2 Defendant BARNEY'S WORLDWIDE, INC. has failed to reasonably, equitably, or adequately
3 inform California based consumers that the Subject Food Product does not contain "Kobe" beef.

4 **JURISDICTION AND VENUE**

5 6. This class action is brought pursuant to the California Code of Civil Procedure
6 section 382. The monetary damages and restitution sought by Plaintiff exceeds the minimal
7 jurisdiction limits of the Superior Court and will be established according to proof at trial.

8 7. This Court has jurisdiction over this action pursuant to the California
9 Constitution, Article VI, Section 10, which grants the superior court "original jurisdiction in all
10 other causes" except those given by statute to other courts. The statutes under which this action
11 is brought do not specify any other basis for jurisdiction.

12 8. This Court has jurisdiction over the named Defendants and DOES 1 through 100
13 because, upon information and belief, Defendants have sufficient minimum contacts with the
14 State of California or otherwise intentionally avail themselves of the California market so as to
15 render the exercise of jurisdiction over them by the California courts consistent with traditional
16 notions of fair play and substantial justice.

17 9. Venue is proper in this Court because, upon information and belief, Defendants
18 maintain offices, have agents, and/or transact business in the State of California, County of Los
19 Angeles. Plaintiff resides in the State of California, County of Los Angeles and the acts and
20 omissions alleged herein took place in the State of California, County of Los Angeles.

21 **PARTIES**

22 10. Plaintiff KRIKOR "GREGORY" NALBANTIAN ("Plaintiff") resides in the State
23 of California, County of Los Angeles.

24 11. Defendant BARNEY'S WORLDWIDE, INC. is a California corporation that
25 owns and/or operates restaurants within the State of California and County of Los Angeles, and
26 therefore, transacts business in the State of California, County of Los Angeles. Moreover,
27 Defendant BARNEY'S WORLDWIDE, INC., is headquartered within the County of Los
28 Angeles, State of California.

1 17. At all times mentioned in this Complaint, Defendants through their online and/or
2 in-store menus have suppressed and concealed and continue to suppress and conceal the fact that
3 the Subject Food Product does not contain "Kobe" beef. For example, Defendants do not state
4 anywhere in their restaurants, on their website, in their online menus, or in their in-store menus
5 that the Subject Food Product does not contain "Kobe" beef.

6 18. At all times herein relevant, Plaintiff purchased and ate the Subject Food Product
7 at one or more restaurants owned, operated or managed by Defendant, including numerous
8 Barney's Beanery locations, in the State of California, including in the County of Los Angeles,
9 believing and having been led to believe that the Subject Food Product actually contained
10 "Kobe" beef.

11 19. At all times herein relevant, when Plaintiff purchased the Subject Food Product,
12 he was exposed to Defendants' online and/or in-store menus, which did not disclose that the
13 Subject Food Product did not contain "Kobe" beef. To her detriment, Plaintiff relied upon these
14 online and/or in-store menus when purchasing and consuming the Subject Food Product.

15 20. Plaintiff is informed and believes, and based thereon alleges, that Defendants'
16 concealment of the fact that the Subject Food Product does not contain "Kobe" beef, and being
17 explicitly informed by Defendants' online and/or in-store menus that the Subject Food Product
18 contains "Kobe" beef, was the immediate cause of Plaintiff and the other class members
19 consuming the Subject Food Product.

20 21. In light of Defendants' representations and omissions, as alleged herein, regarding
21 the Subject Food Product, Plaintiff and members of the putative class reasonably believed that
22 the Subject Food Product contained "Kobe" beef.

23 22. Plaintiff is informed and believes, and based thereon alleges, as a result of
24 Defendants' false and misleading representations, as alleged herein, Plaintiff has suffered
25 damages including, but not limited to, monetary loss, caused by the fact he was misled by
26 Defendants' online and/or in-store menus into consuming the Subject Food Product, which did
27 not contain "Kobe" beef.

28 ///

CLASS ALLEGATIONS

23. Plaintiff brings this action on his own behalf and on behalf of all other members of the general public similarly situated, and, thus, seeks class certification under Code of Civil Procedure section 382.

24. The proposed class is defined as follows:

All California-based consumers who were exposed to Defendants' online and/or in-store menus, and who purchased the Subject Food Product at or from a BARNEY'S WORLDWIDE, INC. owned, managed and/or operated restaurant located in the State of California at any time during the period of four years preceding the filing of this Complaint to final judgment.

25. Plaintiff reserves the right to establish subclasses as appropriate.

26. The class is ascertainable and there is a well-defined community of interest in the litigation:

- a. Numerosity: The class members are so numerous that joinder of all class members is impracticable. The membership of the entire class is unknown to Plaintiff at this time. The class will include thousands of consumers.
- b. Typicality: Plaintiff's claims are typical of all other class members' as demonstrated herein. Plaintiff will fairly and adequately protect the interests of the other class members with whom he has a well-defined community of interest.
- c. Adequacy: Plaintiff will fairly and adequately protect the interests of each class member, with whom he has a well-defined community of interest and typicality of claims, as demonstrated herein. Plaintiff has no interest that is antagonistic to the other class members. Plaintiff's attorneys, the proposed class counsel, are versed in the rules governing class action discovery, certification, and settlement. Plaintiff has incurred, and during the pendency of this action will continue to incur, costs and attorneys' fees, that have been, are, and will be necessarily expended for the

prosecution of this action for the substantial benefit of each class member.

- d. Superiority: A class action is superior to other available methods for the fair and efficient adjudication of this litigation because individual joinder of all class members is impractical.
- e. Public Policy Considerations: Certification of this lawsuit as a class action will advance public policy objectives. Businesses of this great State violate consumer protection laws every day. Therefore, this action will allow for the vindication of consumers' rights with respect to the Subject Food Product.

27. There are common questions of law and fact as to the class members that predominate over questions affecting only individual members. The following common questions of law or fact, among others, exist as to the members of the class:

- a. Whether Defendants engaged in a pattern or practice of concealing, suppressing and/or misrepresenting in their online and/or in-store menus the fact that the Subject Food Product does not actually contain "Kobe" beef.
- b. Whether Defendants thereby engaged in consumer fraud, deceptive trade practices, or other unlawful acts.
- c. Whether class members are entitled to damages including punitive damages, restitution, disgorgement of profits, and injunctive relief, and the proper measure, nature and extent of such relief.

FIRST CAUSE OF ACTION

(Intentional Misrepresentation)

(Against all Defendants and Does 1 through 100)

28. Plaintiff incorporates by reference the allegations contained in paragraphs 1 through 27, and each and every part thereof with the same force and effect as though fully set forth herein.

29. Defendants represented to Plaintiff and the other class members that important facts were true. More specifically, Defendants represented to Plaintiff and the other class members through their online and/or in-store menus that the Subject Food Product contained "Kobe" beef.

30. Defendants' representations were false.

31. Defendants knew that the representations were false when Defendants made them, or that the Defendants made the representations recklessly and without regard for their truth.

32. Defendants intended that Plaintiff and the other class members rely on the representations.

33. Plaintiff and the other class members reasonably relied on Defendants' representations.

34. Plaintiff and the other class members were financially harmed and suffered other damages including, but not limited to, emotional distress of the type that would naturally flow from said allegations.

35. Plaintiff's and the other class members' reliance on Defendants' representations was the immediate cause of the financial loss and emotional distress (of the type that would naturally from being lead to believe that the food product you are purchasing and consuming contains "Kobe" beef when in fact it does not) sustained by Plaintiff and the other class members.

36. Defendants' misrepresentation and/or nondisclosure were the immediate cause of Plaintiff and the other class members purchasing the Subject Food Product.

1 37. In absence of Defendants' misrepresentation and/or nondisclosure, as described
2 above, Plaintiff and the other class members, in all reasonable probability, would not have
3 purchased the Subject Food Product.

4 **SECOND CAUSE OF ACTION**

5 **(Negligent Misrepresentation)**

6 **(Against all Defendants and Does 1 through 100)**

7 38. Plaintiff incorporates by reference the allegations contained in paragraphs 1
8 through 37, and each and every part thereof with the same force and effect as though fully set
9 forth herein.

10 39. Defendants represented to Plaintiff and the other class members that important
11 facts were true.

12 40. Defendants' representations were not true.

13 41. Defendants had no reasonable grounds for believing the representations were true
14 when Defendants made them.

15 42. Defendants intended that Plaintiff and the other class members rely on the
16 representations.

17 43. Plaintiff and the other class members reasonably relied on Defendants'
18 representations.

19 44. Plaintiff's and the other class members' reliance on Defendants' representation
20 was a substantial factor in causing the financial loss and emotional distress (limited to the type of
21 emotional distress that would naturally flow from said allegations) sustained by Plaintiff and the
22 other class members.

23 45. Defendants' negligent misrepresentation and/or nondisclosure was the immediate
24 cause of Plaintiff and the other class members purchasing the Subject Food Product from
25 Defendants, and thereby sustaining monetary loss and emotional distress of the type that would
26 naturally flow from said allegations.

27 ///

28 ///

1 46. In absence of Defendants' negligent misrepresentations and/or nondisclosure, as
2 described above, Plaintiff and the other class members, in all reasonable probability, would not
3 have purchased the Subject Food Product from Defendants.

4 **THIRD CAUSE OF ACTION**

5 **(Fraud)**

6 **(Against all Defendant and Does 1 through 100)**

7 47. Plaintiff incorporates by reference the allegations contained in paragraphs 1
8 through 46, and each and every part thereof with the same force and effect as though fully set
9 forth herein.

10 48. The misrepresentations, nondisclosure and/or concealment of material facts made
11 by Defendants to Plaintiff and the other class members, as set forth above, were known by
12 Defendants to be false and material and were intended by Defendants to mislead Plaintiff and the
13 other class members.

14 49. Plaintiff and the other class members were actually misled and deceived and were
15 induced by Defendants to purchase the Subject Food Product.

16 50. Defendants had a duty to disclose that the Subject Food Product did not contain
17 "Kobe" beef because this information was a material fact of which Defendant had exclusive
18 knowledge; Defendant actively concealed this material fact; and Defendant made partial
19 representations about the Subject Product but suppressed some material facts. Had Plaintiff and
20 the other class members known that the Subject Food Product did not contain "Kobe" beef, they
21 would not have purchased the Subject Food Product.

22 51. Defendants' misrepresentation and/or nondisclosure were the immediate cause of
23 Plaintiff and the other class members purchasing the Subject Food Product.

24 52. In the absence of Defendants' misrepresentation and/or nondisclosure, as
25 described above, Plaintiff and the other class members, in all reasonable probability, would not
26 have purchased the Subject Food Product.

27 ///

28 ///

1 58. Defendants' misrepresentation and/or nondisclosure of the fact that the Subject
2 Food Product did not actually contain "Kobe" beef were the immediate cause of Plaintiff and the
3 other class members purchasing the Subject Food Product.

4 59. In the absence of Defendants' misrepresentation and/or nondisclosure, as
5 described above, Plaintiff and the other class members would not have purchased the Subject
6 Food Product.

7 60. Plaintiff and the other class members are entitled to relief, including full
8 restitution and/or disgorgement of all revenues, earnings, profits, compensation, and benefits
9 which may have been obtained by Defendants as a result of such business acts or practices, and
10 enjoining Defendants to cease and desist from engaging in the practices described herein.

11 **FIFTH CAUSE OF ACTION**

12 **(Violation of the California Unfair Business Practices Act –**

13 **Business & Professions Code §§ 17200, et seq.)**

14 **(Against all Defendant and Does 1 through 100)**

15 61. Plaintiff incorporates by reference the allegations contained in paragraphs 1
16 through 60, and each and every part thereof with the same force and effect as though fully set
17 forth herein.

18 62. California Business and Professions Code section 17200 prohibits any "unfair
19 deceptive, untrue or misleading advertising." For the reasons discussed above, Defendants have
20 engaged in unfair, deceptive, untrue and misleading advertising in violation of California
21 Business & Professions Code sections 17200, et seq.

22 63. California Business & Professions Code section 17200 also prohibits any
23 "unlawful . . . business act or practice." Defendants have violated Sections 17200, et seq.'s
24 prohibition against engaging in unlawful acts and practices by, among other things, making the
25 representations and omissions of material facts, as set forth herein, and violating, among other
26 things, Section 1770 of the Consumers Legal Remedies Act. Defendants violated Section 1770
27 by: misrepresenting the source of goods (California Civil Code § 1770(a)(2)); using deceptive
28 representations of geographic origin in connection with goods (California Civil Code §

1 1770(a)(4)); representing that goods have a characteristic that they do not have (California Civil
2 Code § 1770(a)(5)); representing that goods are of a particular standard, quality or grade when
3 they are of another (California Civil Code § 1770(a)(7)); and advertising goods with the intent
4 not to sell them as advertised (California Civil Code § 1770(a)(9)).

5 64. Business & Professions Code sections 17200, et seq. also prohibits any
6 “fraudulent business act or practice.” Defendants’ claims, nondisclosures, and misleading
7 statements, as set forth above, were false, misleading, and/or likely to deceive reasonable
8 consumers within the meaning of Business & Professions Code sections 17200, et seq.
9 Defendants’ business acts and practices are fraudulent because they are likely to, and in fact, did
10 deceive reasonable consumers, including Plaintiff and the other class members, into believing
11 that the Subject Food Product contains “Kobe” beef.

12 65. Plaintiffs and the other class members reserve the right to allege other violations
13 of law which constitute other unlawful business acts or practices. Such conduct is ongoing and
14 continues to this date.

15 66. Defendants had a duty to disclose that the Subject Food Product did not contain
16 “Kobe” beef because this information was a material fact of which Defendant had exclusive
17 knowledge; Defendant actively concealed this material fact; and because Defendant made partial
18 representations about the Subject Product but suppressed some material facts. Plaintiff and the
19 other class members would not have purchased the Subject Food Product had they known that
20 the Subject Food Product did not actually contain “Kobe” beef.

21 67. Defendants’ acts, omissions, misrepresentations, practices and non-disclosures as
22 alleged herein also constitute “unfair” business acts and practices within the meaning of Business
23 & Professions Code sections 17200, et seq. in that Defendants’ conduct is substantially injurious
24 to consumers, offends public policy, and is immoral, unethical, oppressive, and unscrupulous as
25 the gravity of the conduct outweighs any alleged benefits attributable to such conduct. Plaintiff
26 asserts violations of the public policy of engaging in false and misleading advertising, unfair
27 competition, and deceptive conduct towards consumers. There were reasonable alternatives
28 available to further Defendants’ legitimate business interests, other than the conduct described

1 herein. This conduct constitutes violations of the unfair prong of California Business &
2 Professions Code sections 17200, et seq.

3 68. Defendants' misrepresentations and/or nondisclosure of the fact that the Subject
4 Food Product contained "Kobe" beef were the immediate cause of Plaintiff and the other class
5 members purchasing the Subject Food Product.

6 69. As a result of Defendants' misrepresentations and omissions, Plaintiffs and the
7 other class members lost money or property because had they known the Subject Food Product
8 does not actually contain "Kobe" beef, they would not have purchased it from Defendants, but
9 rather, they would have used their money to purchase another product.

10 70. Defendants' conduct caused and continues to cause substantial injury to Plaintiff
11 and the other class members. Plaintiff and the other class members have suffered injury in fact
12 and have lost money as a result of Defendants' wrongful conduct.

13 71. Pursuant to Business & Professions Code section 17203, Plaintiff and the other
14 class members seek an order requiring Defendants to immediately cease such acts of unlawful,
15 unfair, and fraudulent business practices and requiring Defendants to engage in a corrective
16 advertising campaign.

17 72. Unless Defendants are enjoined from continuing to engage in these unfair,
18 unlawful and fraudulent business practices, Plaintiff and the other class members will continue to
19 be injured by Defendants' actions and conduct.

20 73. Defendants have thus engaged in unlawful, unfair, and fraudulent business acts
21 and practices, entitling Plaintiff and the other class members to judgment and equitable relief
22 against Defendants, as set forth in the Prayer for Relief, including full restitution and/or
23 disgorgement of all revenues, earnings, profits, compensation, and benefits which may have been
24 obtained by Defendants as a result of such business acts or practices, and enjoining Defendants
25 to cease and desist from engaging in the practices described herein.

PRAYER FOR RELIEF

WHEREFORE, Plaintiff, individually and on behalf of all other members of the general public similarly situated, prays for relief and judgment against Defendants, and each of them, jointly and severally, as follows:

Class Certification


1. That this action be certified as a class action;
2. That Plaintiff be appointed as the class representative;
3. That counsel for Plaintiff and the putative class be appointed as class counsel;

As to the First through Fifth Causes of Action

4. That Plaintiff and the other class members be awarded compensatory and general damages according to proof;
5. That Plaintiff and the putative class be awarded restitution and/or disgorgement and other equitable relief as the Court deems proper;
6. That Plaintiff and the other class members be awarded interest on the monies wrongfully obtained from the date of collection through the date of entry of judgment in this action;
7. For injunctive relief to ensure compliance with the California False Advertising Act and the California Unfair Business Practices Act;
8. That Plaintiff and the other class members be awarded punitive damages as to the appropriate cause of action;
9. That Plaintiff and the other class members be awarded their reasonable attorneys' fees, expert witness fees, and other costs pursuant to statutes as may be applicable; and
10. All such other and further relief as the Court deems just and proper.



Burgers and coffee shared the menu with the chili that would become a mainstay. There was no bar at that time and the spirits were not served until after prohibition was repealed. When that happy day arrived Barney built a bar in the breezeway of his neighboring and against the western exterior wall of a neighboring warehouse. The restaurant's dining customers' drinks were handed to waitresses through an open window. As time and capital allowed a roof was added and walls pushed out to create the tavern. The bar has long since been replaced by the very functional, well used, wooden edifice that we belly up to today... (continued on page 3)

I have read somewhere that Barney's was featured in a sketch that graced one of Janis' albums. One album is "Cheap Thrills-Big Brother and the Holding Company." The Beanyery is shown in the second drawing from the bottom right. Barney's was also a favorite hangout of Peter Paul. The actual Beanyery shows up in quite a few Columbo episodes. (although in later years a studio set filled in for the famous eatery) Yes, film and television personalities have, for as long as many can remember, been part of Barney's mystique, but the real magical presence here is that of music. To say "Rock and Roll lives at Barney's" is simply true. Really! ...I wonder what it's like to hear yourself on the 1 wonder if Jimi did? Jimi Hendrix used to frequent this rock icon of a tap house when he lived above the Whisky A Go-Go just a few blocks away. Mr. Irwin Held, is the hard working industrious man that bought the place from the original owner in the early nineteen seventies. Irwin operated the Beanyery for nearly thirty years and is considered by some to be a pioneer in many hospitality industry trends. Barney's had at one time as many as forty-seven beers on tap when most places had only two or three. The dining room quiets down a little bit after lunch, and the walls are laden with interesting lore.

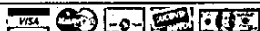

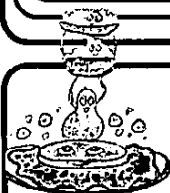

...needs of an eating and meeting house. The original structure was just an ordinary California bungalow converted into a small restaurant. Burgers and coffee shared the menu with the chili that would become a mainstay. There was no bar at that time and the spirits were not served until after prohibition was repealed. When that happy day arrived Barney built a bar in the breezeway of his neighboring and against the western exterior wall of a neighboring warehouse. The restaurant's dining customers' drinks were handed to waitresses through an open window. As time and capital allowed a roof was added and walls pushed out to create the tavern. 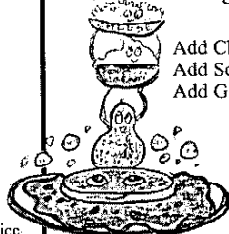

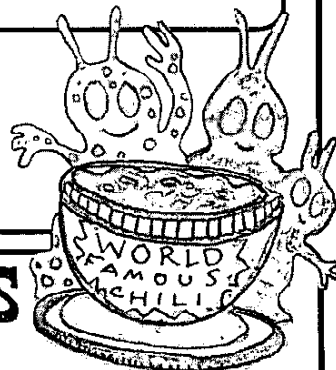

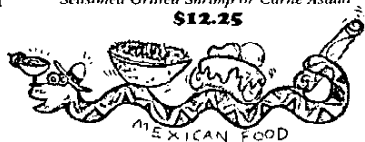
