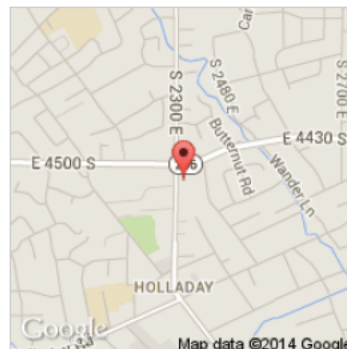

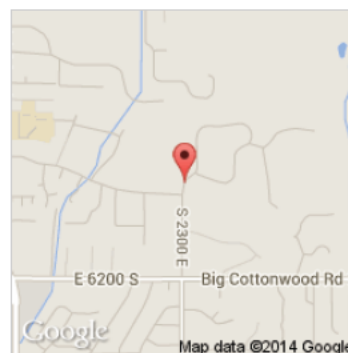

Comments: I was researching online for an E-Cigarette starter kit and came across this company called VAPEX. They seemed to have a nice product so I placed my order for a "trial offer" of an E-Cigarette on November 15 and was charged \$4.95 shipping, with which I had no problem. They even had one of their reps, Mike20, call me to make sure I got the flavor I wanted since I had failed to indicate it in my order. My problem with this company is that in the fine print it says I have 12 days to "sample" the product and if I do not return the product at the end of those twelve days, I will be charged the full price of \$99.95. HOWEVER, my shipment didn't arrive until DECEMBER 3, a full 16 days after I ordered it. I was charged \$99.95 that same day, Dec. 3 to my VISA. When I saw this charge I had not even had a chance to open the product yet. I called my VISA card company and told them about the problem. They immediately cancelled my VISA, and opened an investigation for me. I took the package and wrote "Return to Sender" on it without ever opening it and mailed it back to VAPEX. Whether or not VAPEX charges me again I don't know yet. No one from their company has contacted me; however I did get a call from an independent company claiming to be auditing VAPEX. This gentleman's name was Alex and his phone number is 248-269-6000. I do not know if this guy was legitimate or not. As of right now, VAPEX cannot charge me anything else as my VISA was closed but they have not yet refunded the \$99.95 that I was charged. My Visa Company has taken charge of the problem for now. 4

They said all that was needed was for me to pay shipping and handling for 4 dollars to which I entered my bank card in and ordered my "free" product. Weeks later on the 30th of December I receive the product that is actually less than what was said to be in the package. On the same day my bank account had an unauthorized charge of 99.95 from them. I found the number for Vapex and called them at 1-800-554-5447 on December 30th. They told me that there was nothing they could do about it because the company that sent the product was called vapor ultra and proceeded to give me their number. I called their number at 888-619-5646 several times and it was not a working number. My bank account did have "vapor ultra" as the one that debited my account, but I had never given my card information to that company or authorized anyone else to take out money. I then called Vapex back and they told me they couldn't help me even though their name and address was on the return envelope of the product I received. I got hung up on twice and am unable to find an email address or another number. I have contacted their Facebook page (https://www.facebook.com/vapexecigs) and see that many people have the same exact complaint as I do. I do not understand how corrupt businesses like this are allowed to still be in practice if they are clearly scamming people. This is not right and something needs to be done about these people.</p>

I worked in the **Scientific Inference Systems Laboratory**, with my PhD advisor, **Prof. Eric Mjolsness**. My research is about computational modeling and inference tools for scientific applications.

I focus on the study of a computational framework that combines stochastic processes and dynamical systems. We developed a simulation software, **Plenum**, for **dynamical grammars**. The dynamical grammar language includes stochastic 'jump' events and continuous dynamical systems (systems of differential equations). I am mostly interested in parameter inference/learning algorithms for these stochastic hybrid models.

We use *Plenum* to model the development of the olfactory epithelium tissue and its stem cell niche.

We worked on another biological application which is modeling and simulation of the root development in *Arabidopsis thaliana*.

Finally, we developed a dynamical grammar model for the formation of spiral galaxies. Based on this galaxy structure model, we have an inference algorithm to recognize galaxy features from images.

What does start to grate however is how each of the 18 stories has a specific environmental theme, which the author then ties in to a human trait, or issue

18 stories 18 themes, with a bit of padding thrown in for good measure (including a poem, a sonnet, and a preface, no less) Those of us involved in environmental activism and protection now that nasty issues appear back and forth, yet often have myriads of layers and interconnectivity underneath the surface

In the story 'Dreaming of a Green Christmas,' Dauncey explores anti-materialism; in 'Cobble Holes,' he examines [eco villages](#) and cooperation In 'Future in the Forests' he weaves his words around sustainable forests, and so on

Back borders on each page mark out three stories in the book's centre pages This seems to imply that these are the best, and they are the sparks of despair that could really bring change in the world They deal with a bacterial outbreak in the UK (that's 4,500 people), the DNA in both humans and monkeys being altered by pollutants (with the resulting outbreak of deformed children and baby monkeys), and it should be pretty clear from the title what 'Antarctica's Farewell' focuses upon These three grim stories serve to focus the reader upon the potential of the optimistic and sustainable outcomes that Dauncey provides in the stories that sandwich these three

He uses these scenarios as edgehammers upon our heads, but in this he's faultless humanity's indeed acting upon the earth is a business, and we know the consequences

"The grandeur of the looming mountains was amplified by the ice-streams that poured down from the glaciers into the sea. Ten kilometres a year did not seem a particularly impressive speed at which to drown the world. Yet there they were, those tongues of ice moving slowly northwards into the ocean, inundating the civilized world at 10 kilometres a year, 27 metres a day. All for a hundred years of fun and fast living, burning a hundred million years of stored solar energy – fossil fuels."

The cumulative effect of this collection's worthiness with a slightly due edge. A different reviewer might examine how much of the stories predictions for the future (it was published 17 years ago) have come true, or not, but that's for others to write. I'm minded of the quote "there are ways of telling, and then there are ways of telling." As the author's blurb on the cover tells us, Dauncey is a futurist, not necessarily a teller of tales. He has yet to perfect this art, or artfully combine the two

For those of us in the Middle East, one of Dauncey's stories contains a German activist's memory of a journey by rail and sea from Berlin to the Middle East. The activist, Mimi, is slowly dying of "drug-resistant tuberculosis" and from her apartment in Berlin looks back upon her life and achievements. The pinnacle of a life spent campaigning in new and original ways for the widespread use of solar technology, was her participation in a conference in [Jordan](#), in which her presentation showed how "the new wave of renewable energy has achieved a momentum"

It's a little far-fetched that the author then indicates that Mimi's tale was the catalyst for the Arab states then capitalising upon its solar energy potential and in partnership with a Japanese company, dominating the world as energy suppliers

At the more research (back when the book was published in 1991) would have shown that the Arab states (and Israel) have long been ahead of the game in this and that international and local cooperation has long been in place, a ongs of the corrupt politics of the oil baron. Only now in 2008, 17 years after Dauncey's book, are we seeing the fruits of this. Check out this [Green Prophet post](#) on this
