The claim that you can see results in as little as 45 minutes is based upon observable results from over 3 million wraps that have been sold. The Company is very careful not to state that a certain number of inches will be lost, as that would not be permissible claim. Although almost all users experience observable results, some do not and others experience variable results.

Regarding our dietary supplement line, claims are made based upon individual ingredient studies. The Company is extremely careful not to make improper health claims, instead only making appropriate structure function claims based upon published ingredient monographs or other scientific research.
