28 Notice is hereby given that The Hertz Corporation (“Hertz”), defendant in the above named case, hereby appeals to the United States Court of Appeals for the Ninth Circuit from the final judgment entered in this action on October 30, 2014 (Dkt. No. 459), and from all orders and rulings merged into that final judgment. This appeal includes, without limitation, (1) the judgment entered on Count One of the First Amended Complaint, finding for Plaintiffs on their claim that Hertz violated NRS § 482.31575; (2) the judgment entered on Count Three of the First Amended Complaint, finding for Plaintiffs on their claim of unjust enrichment; (3) the district court’s Order of

1 March 17, 2010 entering summary judgment on liability issues (Dkt. No. 111); (4) the district court's
2 Order of March 21, 2013 certifying the class and directing an award of restitution and prejudgment
3 interest to the class (Dkt. No. 332); and (5) the resulting determination that plaintiffs are entitled to
4 an award of fees, as permitted in the district court's Order of October 9, 2014 (Dkt. No. 454).
