I called back on 12/10/12 and spoke with Derek who informed me that only \$150 (\$136 + \$14) initial shipping) would be refunded. I argued with him about the \$28.44 that it cost me to ship it Fed Ex. because I could have sent it much cheaper another way. He informed me that he was going to listen to the conversations that are recorded and would let me know. He said the conversation was quite clear, so I asked him to send me the audio, becuase I know that I was quite clear in what I understood as well. He would not send me the audio and was quite clear that the company would not allow that to happen. Derek said he was going to speed up the refund and forward me the confirmation. After several days of not receiving anything and not receiving a refund and Derek not taking my calls, I called again and spoke with Alecia on 12/20/12. She was very friendly and said it would take 3 - 4 weeks for a refund. but did speed up the process and had the refund deposited on 12/21/12. However, Firstbank called to inform me that only \$130 had been deposited (because I filed a dispute with my bank over Vemma, they are watching the account carefully).
