6 GRANTS the stipulation and hereby orders that:

7 1. The following two cases shall be consolidated with the above-captioned
8 consolidated action already pending before this Court:

- 9 • *Eddie Sitt v. Local Lighthouse Corp.*, Case No. 8:15-cv-01604-JVS-
10 JPR;
- 11 • *Christopher Hughson v. Local Lighthouse Corp.*, Case No. CV15-
12 07923-JVS-JPR.


13 2. All Plaintiffs must file and properly serve their First Amended
14 Consolidated Complaint on or before November 20, 2015 that will supersede for all
15 purposes the Consolidated Class Action Complaint previously filed by Plaintiffs
16 Ballon, Barrett, Grundman, and Wick on October 30, 2015.

17 3. No answer, motion, or other response need be filed with respect to
18 Plaintiffs’ Consolidated Class Action Complaint.

19 4. Any answer, motion, or other response to the First Amended
20 Consolidated Complaint must be filed and properly served within 30 days of the filing
21 and proper service of the First Amended Consolidated Complaint.
