ELIGIBILITY

To enter the giveaway, you must be at least 18 years old and a legal resident of the United States. Employees and contractors of CARFAX, and their immediate family and household members, aren't eligible to enter.

GIVEAWAY DATES

The giveaway begins on December 11, 2015 and ends on March 24, 2016. It is divided into fifteen (15) weekly entry periods, each of which starts on a Friday and ends on the following Thursday. For example, the first entry period is from December 11th-17th, and the last entry period is from March 18th-24th. Entries must be received during one of these entry periods to be eligible, and any early or late entries will be disqualified.

HOW TO ENTER

To enter, tell someone you know about myCARFAX, by completing the 'Refer a Friend' form provided by CARFAX. To complete the form, you'll have to provide your name, your email address, and the email address of the person you're referring. You'll also be able to provide a message to that person. When you submit the completed form to CARFAX, you'll be entered into the giveaway.

By providing an email address for the person you're referring, you're authorizing CARFAX to send that person an email with an invitation to use myCARFAX. Information that you provide to CARFAX about yourself and the person you're referring will be handled in accordance with our Privacy Statement (currently posted at <http://www.carfax.com/company/privacy-statement>).

You will only receive one entry per weekly period, even if you submit multiple referral forms during a week. Each entry will be considered only during the entry period in which it was submitted, but you may enter during multiple weeks, by submitting an additional referral form each week.

Message and data charges may apply if you enter with a device using a wireless service provider's network, and you're solely responsible for any such charges.

SELECTION OF WINNERS AND PRIZES

At the end of each weekly entry period, CARFAX will randomly select one (1) winner from all eligible entries submitted during that week. Each winner will be selected in the sole discretion of CARFAX and its agents, whose decisions will be final, subject to verifying the eligibility of each selected winner and entry. The odds of winning depend on the total number of entries received each week. Each entrant may receive only one (1) prize, so if you win during a certain week, you're not eligible to win for the rest of the giveaway.
