PLEASE TAKE NOTICE THAT, pursuant to Rule 4(a)(1)(A)(i) of the Federal
Rules of Civil Procedure, Yossi Tiefenbrun (“Plaintiff”), plaintiff in the action
Tiefenbrun v. Eagle Eye Marketing Group, Inc., Case No. 3:15-cv-02842-CAB-KSC
(S.D.C.A.), hereby voluntarily dismisses his action against the defendant without
prejudice.

On December 17, 2015, Plaintiff filed a Class Action Complaint in the United
