Plaintiffs Candace Hiddlestone and Julie Hedges (“Plaintiffs”) and Defendant The Honest Company, Inc. (“Honest”) (Plaintiffs and Honest, collectively the “Parties”) hereby submit this Joint Status Report to Notify the Court of Final Approval.

The Court in the *Buonasera* case (*Buonasera v. The Honest Company, Inc.*, Case No. CV 16-01125 granted final approval of the Class Settlement on December 8, 2017.

Within five (5) business days after that Order becomes final – 31 days after the date of final approval (Jan. 8, 2018) unless there are any appeals – Plaintiffs anticipate requesting dismissal of this action and the parallel *Michael v. Honest Company, Inc.*, No. 2:15-cv-07059-JAK-AGR action with prejudice.
