2 Plaintiffs Shane Michael, Jonathan D. Rubin, Dreama Hembree and Ethel
3 Lung (“Plaintiffs”) and Defendant Honest Company, Inc. (“Honest”) (Plaintiffs
4 and Honest, collectively the “Parties”) hereby submit this Joint Status Report in
5 response to the Court’s February 27, 2017 Order staying this matter and placing it
6 on the Court’s inactive calendar pending the Parties’ negotiation of final class-wide
7 settlement terms. (Dkt. No. 99.)

8 The Parties have reached a final long form class-wide settlement agreement
9 and that agreement will soon be sent out for signature. The Parties have also
10 agreed that the approval process will be handled in the parallel *Buonasera v. The*
11 *Honest Company, Inc.*, No. 16-cv-01125 action, currently before the Honorable
12 Victor Marrero in the Southern District of New York.

13 Accordingly, the Parties respectfully request that this action and the parallel
14 *Hiddlestone v. The Honest Company, Inc.*, No. 2:16-cv-07054 action be stayed
15 pending final approval of the *Buonasera* court. The Parties further respectfully
16 request that the June 12, 2017 Status Conference be taken off calendar.
