

- 7 (3) Provided that no appeal(s) is filed regarding the Final Approval of the Class Action
8 Settlement, Defendant shall fund the an account with Class Action Administration in an
9 amount great enough to pay all valid claims on or before April 29, 2016;
- 10 (4) Provided that no appeal(s) is filed regarding the Final Approval of the Class Action
11 Settlement, Class Action Administration shall mail refund checks to Class Members
12 who submitted valid Claim Forms on or before May 6, 2016.
- 13 (5) Provided that no appeal(s) is filed regarding the Final Approval of the Class Action
14 Settlement, Class Counsel and Class Action Administration shall file declarations
15 confirming that claims have been paid to Class Members pursuant to this Order on or
16 before May 31, 2016;
- 17 (6) The Objection of Steven Helfand is OVERRULED;
- 18 (7) The Objection of Victor Gabler is OVERRULED;
- 19 (8) Class Representative Stephen Colucci is awarded a Class Representative fee in the
20 amount of \$ 5,000⁰⁰ to be paid in accordance with the Settlement
21 Agreement;
- 22 (9) Class Counsel is awarded costs in the amount of \$ 6730⁰⁰ ;
