JOINT STATUS REPORT

Tween Brands, Inc. d/b/a Justice (“Justice”) and Plaintiff Yanetsy Loor (“Loor”) hereby submit this Joint Status Report as directed by this Court in its August 1, 2017 Order. *See* Doc. No. 35.

On July 29, 2016, Judge Mark A. Kearney granted final approval of the nationwide class settlement in the related matter, *Rougvie, et al. v. Ascena Retail Group, Inc., et al.*, No. 2:15-cv-00724 (E.D. Pa.), encompassing all claims January 1, 2012 – February 28, 2015. A number of objectors did challenge Judge Kearney’s opinion on appeal to the Third Circuit Court of Appeals. No. 16-3381; No. 16-3409; No. 16-3421; No. 16-3472; No. 16-3471; No. 16-3473; No. 16-3514; No. 16-3515; No. 16-3516; No. 16-3517; No. 16-3518; No. 16-3519. Those appeals were all dismissed or resolved through settlement by April 2017 and, as a result, the settlement is now final and non-appealable. Currently, the claims administrator is working with class counsel and Justice to distribute vouchers and cash to the more than 18 Million Class Members. *See* Joint Status Report, Dkt. No. 304, Case No.: 2:15-cv-724 (E.D. Pa. July 17, 2017).

Plaintiff Loor is a class member under the *Rougvie* settlement given that her purchases on December 3, 2014 and February 5, 2015 are within the class period (*see* Dkt. No. 1 at ¶¶ 17, 19) and because Ms. Loor did not opt out of the settlement. Under the *Rougvie* settlement, Ms. Loor will receive a voucher or cash, depending on her election during the claims period. Accordingly, the parties agree that this case should now be dismissed with prejudice.
