Plaintiffs Christie Kautsky and Susan Balmer (“Plaintiffs”) and Defendant My Pillow, Inc. (“Defendant”), through their respective counsel, and subject to approval of this Court, hereby stipulate as follows:

1. This case was originally filed in this Court on January 11, 2017.
2. The parties have reached an agreement in principle to resolve the case.

3. Plaintiffs and Defendant continue to move toward finalizing the settlement agreement and seeking to effectuate preliminary and final approval in connection with related cases filed in other jurisdictions.
4. Plaintiffs and Defendant have agreed to present the settlement agreement for approval in the *Amiri, et al. v. My Pillow, Inc.* (Case No. CIVDS1606479) matter currently pending in the Superior Court for the State of California.
5. Plaintiffs and Defendant wish to stay all further action in this proceeding until final approval has been obtained and related appeals, if any, have concluded.
6. Accordingly, Plaintiffs and Defendant jointly request that these proceedings be stayed indefinitely, subject to the right of any party to terminate the stay upon thirty (30) days written notice to all counsel of record. The Plaintiffs and Defendant further agree to provide a status report to the Court by February 28, 2018, if the case has not been completely resolved by then.

For the foregoing reasons, the parties respectfully request that the Court enter an Order staying all further proceedings in this matter.
