Dear Judge Batts:

We represent Defendants MoviePass, Inc. (“MoviePass”) and Helios and Matheson Analytics Inc. (“Helios,” and together with MoviePass, “Defendants”). We write to advise Your Honor that, yesterday, January 28, 2020, each Defendant filed a petition for voluntary Chapter 7 bankruptcy with the United States Bankruptcy Court for the Southern District of New York, Case Nos. 20-10243 (MoviePass) and 20-1042 (Helios). Accordingly, the continued litigation in this action of all claims asserted by Plaintiffs has been stayed, pursuant to 11 U.S.C. § 362(a)(1), until such time as the above bankruptcy cases have been closed or dismissed, or discharges have been granted or denied to Defendants. *See* 11 U.S.C. § 362(c)(2).
