**GRANTING JOINT
STIPULATION TO SET
DEADLINE FOR PLAINTIFF TO
AMEND COMPLAINT AND SET
BRIEFING SCHEDULE [36]**

1 Pursuant to the Joint Stipulation to Set Deadline For Plaintiff To Amend
2 Complaint And To Set Briefing Schedule submitted by plaintiff Helen Xiong aka
3 Huiqin Xiong (“Plaintiff”) and defendant Jeunesse, LLC (“Jeunesse”) (collectively,
4 “the Parties”), and good cause appearing therefor, IT IS HEREBY ORDERED that
5 the Parties Stipulation is GRANTED and:

6 (1) **The stay is lifted** and Plaintiff shall file a First Amended
7 Complaint by May 6, 2019;

8 (2) By June 7, 2019, Defendants shall file a motion or motions to (a)
9 dismiss such claims as Defendants contend were released by operation of the
10 finally-approved class action settlement in *Aboltin v. Jeunesse, LLC, et al.*,
11 No. 6:17-cv-01624-PGB-TBS (M.D. Fla.); (b) compel arbitration pursuant to
12 the contract between Plaintiff and defendant Jeunesse, LLC; and (c) transfer
13 this action to the United States District Court for the Middle District of
14 Florida pursuant to that contract;

15 (3) The above-referenced motions shall be noticed for July 22, 2019.
16 Plaintiff shall file her oppositions to the above motions by June 24, 2019, and
17 Defendants shall file their repl(ies) by July 8, 2019;

18 (4) Defendants may file a Rule 12(b)(6) motion after the Court rules on
19 the motions addressed by this Stipulation.
