The Court having granted in part the Plaintiffs' Motion to Consolidate and Appoint Interim Class Counsel (the "Galvan Motion") filed in Andre Galvan v. Smashburger IP Holder, LLC, et al., No. LA CV19-00993 JAK (JEMx) (the "Galvan Action"), this action is now consolidated with the Galvan Action. In light of the foregoing, Plaintiff's Motion to Consolidate and Appoint Interim Class Counsel (the "Motion") (Dkt. 13) is **MOOT**.

In light of the consolidation and to ensure an efficient and fair pretrial and trial process for the two actions, the Court **ORDERS** the following:
