Proceedings (In Chambers): ORDER CONSOLIDATING THE RELATED CASES

On February 11, 2020, the Court granted the stipulation of various parties to consolidate numerous related cases into *In re: Ring LLC Privacy Litigation* (the “Consolidated Action”), Case No. 19-10899. (Consolidated Action Docket No. 19). Pursuant to that Order, “[a]ny action subsequently filed, transferred or removed to this Court that arises out of the same or similar operative facts as the Consolidated Action will be consolidated with it for pre-trial purposes.” (*Id.* at 4). Further pursuant to that Order, “[a]ny attorney who has filed an action in this litigation may file an application for appointment as interim class counsel or other designated counsel either individually or as part of a proposed leadership structure.” (*Id.*).

Subsequently, on March 5, 2020, *Abhi Sheth v. Ring LLC*, Case No. 20-1538 (the “*Sheth* Action”) was transferred to this Court because it arose out of the same or similar operative facts as the Consolidated Action. (*Sheth* Action Docket No. 11).

Accordingly, the Court **ORDERS** that (1) the *Sheth* Action is consolidated into the Consolidated Action for all discovery and pretrial purposes; (2) should counsel in the *Sheth* Action wish to file an application for appointment as interim class counsel or other designated counsel either individually or as part of a proposed leadership structure, they must do so by **April 16, 2020**; and (3) if counsel for the *Sheth* Action submit such applications, counsel in the Consolidated Action may file a response by **April 30, 2020**. Any submission by counsel in the *Sheth* Action shall not exceed five
