**STIPULATION OF DISMISSAL**

1 Pursuant to the Court’s January 19, 2022, Order directing the parties to file a status  
2 update upon the final disposition of the arbitration proceedings (Dkt. No. 42), Plaintiff Elaine  
3 Dougan and Defendant The Children’s Place, Inc. hereby provide the following update:

4 WHEREAS, upon reaching a private settlement in the matter, the parties filed a  
5 stipulation and order of dismissal in their arbitration proceedings on June 27, 2022.

6 WHEREAS, on June 29, 2022, the arbitrator granted the parties’ stipulation and order  
7 of dismissal and closed the arbitration.

8 Pursuant to Federal Rule of Civil Procedure 41(a)(1)(A)(ii), Plaintiff and Defendant  
9 hereby STIPULATE and AGREE to voluntarily dismiss the entirety of this civil action on the  
10 following terms:

11 1. That all of Plaintiff Elaine Dougan’s individual claims alleged against  
12 Defendant The Children’s Place, Inc., in the operative Class Action Complaint (Dkt. No. 1) be  
13 dismissed with prejudice.

14 2. That all of Plaintiff Elaine Dougan’s claims alleged against Defendant The  
15 Children’s Place, Inc., on behalf of the putative class defined in Paragraph 32 of the Class  
16 Action Complaint be dismissed without prejudice.
