**JOINT STIPULATION AND
ORDER TRANSFERRING CASE TO
THE UNITED STATES DISTRICT
COURT FOR THE SOUTHERN
DISTRICT OF NEW YORK**

Pursuant to 28 U.S.C. § 1404, Plaintiff Joseph Sanders (“Plaintiff”) and Defendant 4E Brands North America, LLC (“4E Brands”) (collectively, the “Parties”), through their respective counsel, hereby stipulate to entry of the concurrently filed [Proposed] Order, subject to Court approval, which would transfer this case, for all purposes, to the United States District Court for the Southern District of New York. In support of this Stipulation, the parties further state:

1. This is one of two putative class actions filed against 4E Brands that are based on similar allegations regarding 4E Brands’ hand sanitizers. The other, first-filed case is *Pepe v. 4E Brands North America LLC*, No.: 7:20-cv-06494-VB, which was filed on August 14, 2020 and is currently pending in the United States District Court for the Southern District of New York.

2. In order to conserve judicial and Party resources, the Parties hereby agree and stipulate, subject to Court approval, to the transfer of this case to the United States District Court for the Southern District of New York for all purposes, including trial.

3. After the transfer is complete, the Parties plan to request that the court in the Southern District of New York consolidate the cases.

NOW THEREFORE, in light of the foregoing, the Parties hereby stipulate and agree, subject to Court approval, to transfer this case to the United States District Court for the Southern District of New York.
