**OBJECTION OF FRANK MARI**

COMES NOW, the undersigned Class Member and Objector, hereby files and serves the Objection of Frank Mari pursuant to the Order Granting Motion for Preliminary Approval of a Class Action Settlement, Conditionally Certifying a Class for Settlement Purposes, Directing the Issuance of Class Notice, and Scheduling a Final Approval Hearing (Doc. 107).

1. For brevity and efficiency, the undersigns joins, adopts, and incorporates by reference the legal argument of the Objection of Jed Nolan (Doc. 113 at 8-27) regarding the specific reasons for the undersigned's objection to the settlement and a detailed statement of the legal basis for such objections.

2. The undersigned does not intend to call any other individual to testify at the Final Approval Hearing. The undersigned had no desire and has no desire to obtain a Spartan+ Membership, nor would such membership be of any meaningful benefit to the undersigned during the term of such membership provided under the settlement. From the undersigned perspective, the settlement vouchers are valueless and are not equivalent to cash relief of the same nominal value.

3. The undersigned is a Class Member. From the inception of the Class Period to present, the undersigned has resided in the United States. During the Class Period (February 26, 2016 to December 31, 2020 (inclusive of both dates)), on two separate occasions, the undersigned paid a \$14.00 “Racer Insurance Fee” or additional fee for “insurance” in connection with races organized and sponsored by Spartan. Documents reflecting such payments are attached as Exhibit 1 and Exhibit 2 to this objection. The undersigned is not a board member or executive-level officer of Defendant. The undersigned is not a federal district judge or magistrate judge assigned to this action or court staff of any federal district judge or magistrate judge assigned to this action. The undersigned has not submitted a valid, timely exclusion/opt-out request.

4. The undersigned has not objected to any class action settlement within the five years preceding the date of this objection.

5. The undersigned intends to appear at the Final Approval Hearing. (*See also* Doc. 116 at 1).

6. The undersigned is an attorney admitted to the Florida Bar and bar of this Court, among others, but has not represented any objector in any previous class action.

7. I hereby certify under penalty of perjury, pursuant to 28 U.S.C. § 1746, that the factual information provided herein is true and correct.
