

Get a piece of \$10,000,000 if Gronk kicks a field goal LIVE during FanDuel's Super Bowl commercial. Just place a \$5 bet on the game to qualify.

How it Works:

1. Place a pre-live, \$5+ wager on Super Bowl LVII, taking place on February 12, 2023. Wager must be placed between 9AM ET on January 9, 2023 and 6:30PM ET on February 12, 2023.
2. If you place a \$5+ wager on Super Bowl LVII, you will receive a bonus if Rob Gronkowski kicks "The Kick of Destiny" on February 12, 2023. Bonus awarded issued as non-withdrawable bonus bets.
3. All pre-live wagers on Super Bowl LVII, including futures wagers, will be eligible for this promotion, as long as the wagers are placed after 9AM ET on January 9, 2023. This promotion is only eligible for online wagering.

Kick of Destiny Bonus TERMS & CONDITIONS

1. Description of Promotion

Welcome to the Kick of Destiny Bonus promotion (the "Promotion") where participants who place a pre-live wager of at least Five Dollars (\$5) on Super Bowl LVII, will receive bonus bets available for use only on the FanDuel Sportsbook ("Sportsbook Bonus Bet(s)") equal to an amount ranging from Five Dollars (\$5) to Twenty Dollars (\$20), upon the completion of "The Kick of Destiny" (as defined below). The total payout of Sportsbook Bonus Bets is expected to be at least Ten Million Dollars (\$10,000,000).

The Promotion is sponsored by Betfair Interactive US, LLC (“FanDuel” or the “Sponsor”), located at 6701 Center Drive West, Suite 1000, Los Angeles, CA 90045. The terms “you” or “your” mean the person to whom a Promotion Bonus (defined below) is issued to upon satisfaction of the terms and conditions set forth in this Promotion. Redemption of the Promotion is expressly conditioned upon acceptance of and compliance with all of these Promotion “Terms and Conditions”. Promotion participants may be required to sign paperwork issued by the Sponsor.

2. Promotion Period

The Promotion will begin at 9:00 AM ET on January 9, 2023, and end at the time of kickoff of Super Bowl LVII, currently anticipated to take place at 6:20PM ET on February 12, 2023 (the “Promotion Period”).

3. Eligibility

The Promotion is only open to individuals who are at least 21 years of age and are physically present in New Jersey, Pennsylvania, Illinois, Indiana, Iowa, West Virginia, Colorado, Tennessee, Virginia, Michigan, Arizona, Connecticut, New York, Louisiana (excluding the following parishes: Caldwell, Catahoula, Franklin, Jackson, LaSalle, Sabine, Union, West Carroll and Winn), Wyoming, Kansas, Maryland, or Ohio at the time they place an Eligible Wager (as defined below) during the Promotion Period. If your social security number is associated with another FanDuel Account in Sponsor's database, you may only earn one Promotion Bonus in respect of all such FanDuel Accounts under this Promotion. Employees, officers and directors of the Sponsor, its affiliates, cable/satellite affiliates, advertising and promotion agencies, retailers, distributors, and each of such employees’, officers’ and directors’ immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to participate in the Promotion or receive a Promotion Bonus. 4. Action Required

During the Promotion Period, use your FanDuel Account to place a pre-game wager on Super Bowl LVII of at least Five Dollars (\$5) (the “Eligible Wager”). There is a limit of one (1) Eligible Wager per person. All Super Bowl LVII markets will be eligible for this promotion. You may place a straight wager or a same game parlay, as long as all legs are on Super Bowl LVII markets.

5. Claiming Promotion Offer

If you place an Eligible Wager, regardless of if your Eligible Wager wins or loses, you will receive Sportsbook Bonus Bets equal to an amount ranging from Five Dollars (\$5) to Twenty Dollars (\$20) (“Promotion Bonus”) if Rob Gronkowski kicks a field goal live during the third quarter of Super Bowl LVII (the “Kick of Destiny”). If applicable, the Promotion Bonus will be credited to your FanDuel Account within seventy-two (72) hours of the completion of the Promotion Period. FanDuel reserves the right to pay out the Promotion Bonus if the Kick of Destiny is not completed, or the field goal is missed. Prizes will not be awarded based on chance.

Sportsbook Bonus Bets may be used to wager on any market in the FanDuel Sportsbook. If a wager placed using a Sportsbook Bonus Bet wins, you will receive as withdrawable cash the winnings portion of such wager, and will not receive the stake portion from such wager. The Promotion Bonus can be found in the betslip window of your FanDuel Account. You must manually select the Sportsbook Bonus Bet in the betslip window of your FanDuel Account in order to redeem the Promotion Bonus. Promotion Bonus recipients will be solely responsible for all federal, state, and local taxes, and for any other fees or costs associated with the Promotion Bonus received, regardless of whether the Promotion Bonus, in whole or in part, is used. The Promotion Bonus value may be reported for tax purposes as required by law. 6. Registration Procedures

To qualify for the Promotion, eligible individuals must have an active FanDuel member account (“FanDuel Account”) and verify your identity in order to play on the FanDuel Sportsbook. Creating a FanDuel Account at www.fanduel.com or <https://sportsbook.fanduel.com> is free. By submitting your information and creating a FanDuel Account, participants will be required to agree to the FanDuel Privacy Policy and Terms. If you do not agree to FanDuel’s Terms and Privacy Policy, you cannot create a FanDuel Account or participate in this Promotion.

7. Limitations on Participation

In addition to the eligibility requirements in Section 3, FanDuel reserves the right to refuse or otherwise restrict your eligibility to participate in any Promotion for any reason, in our sole discretion, including based on your wagering patterns or wagering history or if you failed to take advantage of any previous Promotion in good faith. This Promotion is void where prohibited by law. Limit of one (1) Promotion Bonus per person.

8. Wagering Requirements/Exclusions

Any wager placed prior to the start of the Promotion Period or after the expiration of the Promotion Period will not be deemed an Eligible Wager. In-play wagers will not be deemed an Eligible Wager and wagers that are settled using the “Cash Out” feature will not be deemed an Eligible Wager.

9. Order of Funds Used for Wagering

Sportsbook Bonus Bets must be manually selected in the betslip window of your FanDuel Account in order to be used before deposited funds when wagering.

10. Eligible Games

Super Bowl LVII, which takes place on February 12, 2023.

Sportsbook Bonus Bets received as the Promotion Bonus may be used to wager on any market available on the FanDuel Sportsbook except for Round Robin wagers.

11. Restrictions on Withdrawal

The Promotion Bonus is not transferable and cannot be substituted except in the Sponsor's sole discretion. The Promotion Bonus is non-withdrawable but any winnings therefrom are immediately withdrawable. Any unused portion of the Promotion Bonus will be automatically withdrawn from your FanDuel Account seven (7) days after being credited to your FanDuel Account. You may withdraw your deposited funds without penalty at any time.

12. Complaints & Cancellation

Should you wish to cancel your participation in this Promotion at any time, please contact customer support at <https://support.fanduel.com/s>. Additionally, cancellation of an Eligible Wager will remove you from participation in this Promotion. Upon cancellation, you may withdraw any funds you have deposited into your account without restriction. However, any Promotion Bonus amount in your account may not be withdrawn. For customers located in New York, complaints may be filed directly with the New York State Gaming Commission.
