**JOINT STATUS REPORT AND STIPULATED MOTION TO CONTINUE STAY**

Plaintiff Deborah O’Dea and Defendant Premium Brands Opco LLC (“Premium Brands”) (collectively, “the Parties”) jointly submit this status report, pursuant to the Court’s December 4, 2024 Order Granting the Parties’ Joint Motion to Continue Stay. ECF No. 16.

On August 22, 2024, the Parties participated in a private, in-person mediation before mediator Robert A. Meyer. After continued negotiations, the Parties have reached a tentative settlement agreement that will result in the dismissal of this action.

The Parties have exchanged the draft settlement agreement multiple times, and it is very nearly ready to be finalized, which has been somewhat delayed as a result of the holidays. The Parties are in agreement on all of the material terms and at this time are negotiating the language on a few remaining items. The Parties fully expect it to be complete and ready for finalization soon. The Parties therefore mutually request an Order continuing the stay for another thirty (30) days, at which time—if the action has not yet been dismissed—they will report to the Court on the status of the settlement.
