1 **NOTICE OF SETTLEMENT**

2 Pursuant to Local Rule 40-2, Plaintiff Calvin Love (“Plaintiff”) hereby  
3 notifies this Honorable Court that the parties have reached an agreement in  
4 principle to settle this case. The parties’ settlement provides for this case to be  
5 dismissed (i) with prejudice as to Plaintiff’s individual claims, and (ii) without  
6 prejudice as to the class allegations. *See* Judge Virginia A. Phillips, *et al.*, Rutter  
7 Group Prac. Guide Fed. Civ. Pro. Before Trial Ch. 10-C ¶ 10:790 (2022 ed.)  
8 (“Cases filed as purported class actions often settle *without having been certified*  
9 as such. The settlement agreement may provide only for the named plaintiffs’  
10 individual claims and require the class action allegations to be dismissed without  
11 prejudice. There is no requirement of judicial approval for precertification  
12 dispositions. The reason is that absent class members generally have no notice of  
13 uncertified class actions and therefore cannot be bound or deemed to have relied  
14 thereon.”) (emphasis in original) (citing Adv. Comm. Notes to 2003 Amendments  
15 to Fed. R. Civ. P. 23).

16 The parties, through counsel, are working cooperatively to consummate a  
17 long-form settlement agreement. The parties anticipate filing a stipulation for  
18 dismissal within 30 days.
